Brad Banister is a native Albertan, who started playing lacrosse in Calgary at the age of 13. His love for the game began as a Pee Wee player, but evolved over the years. Today, he continues to contribute to the game of lacrosse at both the grassroots and professional level.

Brad began playing lacrosse in 1976 and continued playing competitively until 1987. Over the years, Brad played both Box and Field lacrosse. He played for a number of communities including Lake Bonavista, Willow Ridge and the Calgary Roamers. In 1981, Brad played for Calgary and attended the Canadian National Junior B Box Championship. Then, as a Senior player, he played for the Calgary Shamrocks. In his later years, the love of the game could not keep him away and he returned to the Senior League in 2003, playing for the Okotoks Glaciers.

Even after his playing years were behind him, Brad opted to stay heavily involved with the game of lacrosse. In 1997, Brad founded the Okotoks Mustangs Lacrosse club and is still involved with the club today. At this time, the Box game was limited to Edmonton, Red Deer, and Calgary.

Brad has been involved with the Okotoks Mustangs, in many capacities, throughout the years. He was the coaching director from 1997-2002. In addition, he has coached Novice and Pee Wee teams in 2003; Pee Wee and Bantam in 2004; Pee Wee and Bantam in 2005; Bantam and Midget in 2006; Bantam and Midget in 2007; and Midget in 2008 and 2009. Brad has coached the A teams but has also contributed to the House League teams throughout his lacrosse career. Many of these teams were Calgary and District League Champions and travelled to Alberta Lacrosse Provincial Championships.

Alberta Lacrosse has a program called TEAM ALBERTA which allows the best players to travel to a National Championship at the Pee Wee, Bantam, Bantam Female and Midget level. Brad has participated in this program as both a parent and a coach, as well as providing financial support.

Many of the teams Brad has coached have seen the benefits of travelling outside of Alberta. In 2004, a Pee Wee team travelled to Denver for the Heritage Cup. The Heritage Cup is an All-Star competition between professional lacrosse players from Canada and the US. During half-time, Pee Wee players from Canada competed against those from the US. In 2005, this project was duplicated with a team travelling

to Calgary from Denver to play at the National Lacrosse League All-Star Game's half time show. In 2009, the Okotoks Midget team travelled to Halifax for a lacrosse competition at the Midget level.

In 2003, Alberta entered the ranks of Junior A Lacrosse within the Canadian Lacrosse Association. This was the first year Alberta participated in the Minto Cup. The Minto Cup, which is the second oldest sporting cup vied for, was traditionally a competition limited to British Columbia and Ontario. Alberta won its bid to participate because two organizing groups had the vision to bring lacrosse to the next level in Alberta. One group was the Edmonton Miners and the second was the Calgary Raiders, in which, Brad was a director. Their participation, at the Junior A level, aided in keeping Alberta players in the province to play at a higher level rather than leaving to play with BC and Ontario teams.

Besides his involvement in helping build the grassroots of Alberta Lacrosse, Brad also took time and founded Alberta's first professional lacrosse team in 2001. That same year, the Calgary Roughnecks had their inaugural season. As the team's President and General Manager, Banister helped the province grow lacrosse participation from 4141 players in 2001; to 5852 in 2002; and 8261 players in 2003. The exposure the Calgary Roughnecks gained through TV grew the game even more, with Calgary's neighbors to the north adding a team and stirring up a Battle of Alberta rivalry.

Lacrosse clubs started to grow in rural areas as well. This event probably had the largest affect on the game of lacrosse in Alberta. After nine years in the league, the Roughnecks have been very successful, winning the National Lacrosse League's Champion's Cup in 2004 and 2009.

The Calgary Roughnecks contribute to the grassroots of lacrosse by hosting player development camps, attending lacrosse functions, and by participating in the game of lacrosse as coaches and officials. The Calgary Roughnecks Foundation is a very generous organization which supports minor lacrosse, as well as other charities and provides Scholarships for players of all sports. The Foundation has donated close to half a million dollars to the community.

While taking part in minor lacrosse and professional lacrosse, Brad has found the time to sit on many committees of the National Lacrosse League. Since 2002, he has participated in the Expansion Committee, Competition Committee and the Labour Committee. Brad was named NLL Executive of the year in 2004.
