



ALBERTA CURLING FEDERATION (ACF)
PROVINCIAL CHAMPIONSHIP PARTICIPATION AGREEMENT
2018 Wheelchair Provincial Championship

In consideration of ACF accepting my application to participate in the **2018 Wheelchair Provincial Championship** (the Event), I hereby agree with the following:

1. I acknowledge that I have reviewed the **2017/18 ACF Competitor's Guide** (Guide), available on the ACF Website (under Championships) at www.albertacurling.ab.ca for the Event.
2. I hereby agree to comply with all provisions of the Guide and in particular but without limiting my agreement to comply with all the Rules and the entire Guide, I agree as follows:
 - a) The Guide applies from the time I leave home to attend the event until I return home following the event. That time frame will encompass at least the entire day before the start of the on-ice play at the event and the entire day following the conclusion of the on-ice play at the event, as well as all of the intervening period.
 - b) I understand that the curling **CODE OF ETHICS** is an intrinsic part of the sport of curling generally, and of this event in particular, and I agree to abide by that code.
 - c) I have read and reviewed **CONDUCT** and agree that any conduct in contravention of the Guide that I might engage in will be dealt with by those provisions.
 - d) I have read & reviewed **CODE OF CONDUCT**, of the Guide. In signing this waiver it is understood that the **CODE OF CONDUCT** and appeals process as detailed in the Guide is final and that the individual waives their rights to request any additional measures from:
 - i) the courts of any Province of Canada
 - ii) the domestic courts of any other country; or,
 - iii) the international court or any judicial body to which an appeal may properly be made
3. I agree to comply with all rules and regulations respecting advertising, promotion, and dress codes established by the ACF and its sponsors and communicated to me through the Guide.
4. I consent to ACF and their agent or appointees:
 - a) photographing
 - b) video taping
 - c) filming; and/or
 - d) recording my voice; and further
 - e) exhibiting, publishing, and broadcasting my name or any photographs, video tapes, films, or any other likenesses of me or any sound recordings of my voice in any promotion, reports, or advertising about or in connection with the ACF or the event.
5. I hereby waive the right to any payments or royalties in connection with the actions described in subparagraphs 4 a), b), c) and d) above and in connection with any exhibition, publication or broadcast described in subparagraph 4 e) above, regardless of whether such exhibition, publication or broadcast is on a commercial basis and regardless of whether a fee or rental is charged or paid to anyone in connection with such exhibition, publication or broadcast.
6. For the purpose of promoting the sport of curling during any telecast relating to the event, I consent to:
 - a) being interviewed at the event, and
 - b) wearing, upon the request of the ACF, a portable microphone during competition.

7. I, for myself, my heirs, executors, administrators, and assigns release the ACF, its employees, agents and local organizers from any claims, demands, actions or causes of actions arising out of any loss, injury, or damage to my person or property incurred while traveling to or from, or attending at, or participating in the event, even if any such loss, injury, or damage arises by reason of negligence of the ACF, its employees, agents, or local organizers. Without limiting the generality of the foregoing, I further release any recourse, which I may now or hereafter have resulting from any decision taken by the ACF.
8. I have been given the opportunity to obtain independent legal advice prior to signing this agreement, and fully understand its provisions. No person has attempted to unduly influence my signing of this agreement. I have signed this agreement on my own after careful consideration of all the provisions.
