- **Reminder**: the SPHL President is at the multiplex as a coach, not as an executive; do not approach him regarding SPHL business. Follow the communication chain.

- Provincial bid has been submitted, Atom A could hear back around December 15th
- Atom B teams were initially mis-tiered; games scheduled with the wrong tier may be rescheduled or cancelled, waiting to hear from the league
- 10.4. Female Hockey- Paula Gabourie
 - Schedule is great so far, won first two games
 - Legion concession fundraiser for the Female team during November's Moonlight Madness

- 10.5. Pee Wee Dawn Safar
 - Nothing
- 10.6. Bantam Elissa Ponich
 - November break Power Skating/Skills camps went well, therefore more camps might be offered in the future
 - Minor behaviour incidents from ADMHA players have been noted (off-ice and in the dressing room) during the camp and at school. Parents have approached the Division Director for a solution.
 - Code of Conduct/Harassment Policy needs to be in place for incidents like this

Action Item: President will approach the Code & Conduct Director for a solution. Policies will be expanded upon and updated.

- 10.7. Midget Shelley Roth
 - Midget coaches still need qualifications; Midget B requires at least one coach with "Safety Qualifications"
 - Midget B was changed from Tier 3 to Tier 2, possibly mis-tiered; some are questioning this change as the games with the higher tiered teams have been very uneven. Division Director has been encouraged to contact the League Director with enquiries
 - Lincoln County has donated 10 Edmonton Oiler tickets to be raffled off to benefit 5 ADMHA teams, with the selling of raffle tickets, approximately \$2500 per team could be raised, depending on the number of tickets sold.
 - This does not count toward volunteer hours

MOTION: "To allow 5 teams: Midget A + B, Bantam B, Atom A, Novice 2 to fundraise by raffling donated Oilers tickets."

• Another fundraiser has been suggested for Midget A, a raffle with alcohol as the prize. Previous fundraisers of this type have made upwards of \$5,000. This would help pay for the costs of team travel and to purchase retirement jerseys for the players.

- A HUGE thank you goes out to Colin Hefferan and his 2 apprentices, Brayden Bachnick and Scott Danyluk, for creating platforms for the bottom of each team locker. The platforms will allow us to use each locker from top to bottom now
