 - Complaint letter from several parents
 - Bantam-aged Female team is slotted into shared Peewee ice slots, but parents pay Bantam fees
 - Requesting either Bantam equivalent ice time (non-shared ice) or refund of Bantam/Peewee fee differential
 - Next year the Bantam Female team requests Bantam ice times
 - Would still have to split ice if Female team moved to Bantam practice times as this
 would result in three teams sharing a limited number of slots (4). Ice-sharing is
 required when there are more than three teams in a division.

- Female team can share ice with the Bantam team at the later (Bantam) practice times if they prefer
- Female coach previously approved the earlier (Peewee) ice times

14.0 Referee in Chief – Ron Bay

- No new officials, 5 young referees have dropped out, 2 adults are also quitting.
 Out-of-town officials may need to be called in
- Bantam coaches have been asked if they have any players interested in refereeing; if they are interested they need to register and complete the online courses ASAP; clinic is Saturday November 4th
- Development of officials
 - Novice/Atom/Peewee practice where the officials could officiate the scrimmage (shadowing adults) as a training session. Referee-in-chief will coordinate with the coaches
- \$750 scholarship available to kids who have refereed in the past as enticement to attract more referees (Ron will add it to emails)
- Evaluations
 - The officials will need a game sheet, penalties called, a "normal game", or there will be no officials next year for Evaluations. There were game management issues.
- Out-of-town clinic participants
 - Boyle ref clinic was cancelled, charge \$20 per out-of-town referee to come to Athabasca's clinic

15.0 Information/Roundtable

- Atom B team used a goalie coach that was not a member of ADMHA. Registrar will check what volunteers need to be covered by ADMHA insurance
- Tim Green clinic was not the geared toward goalies, but different skills will be offered in the next sessions; Session was rushed
- Some players have not been wearing neck guards. Players cannot be on the ice without correct equipment for safety
- Add ADMHA meeting dates to the website (Calendar of Events)
- Bantam B wants to host a tournament on Calling Lake ice
 - Per ADMHA policy, there is a budget for tournaments that need to be brought forward
- Annual Timeline should be created for every year. This should be created at the first meeting of the new executive
