1. Call to order: 6:40pm

2. Welcome & Additions to the Agenda

3. Approval of Minutes from September 26th meeting

Brian noted, FMC to travel 1^{st} weekend of both sessions next season, just to clarify Motion to adopt the minutes from September 26^{th} : Pam/LED, 2^{nd} Shannon/ERC, AIF – Carried

4. Scheduler's Report - Sandra

Some ice allocators didn't know about adding 2 games for U10 in the 1st session. There were a few complaints about the timing of the schedule, and about week day games. Associations need to make changes to the policy if they are wanting to change the weekday games. They need to put in a proposal at the AGM if they want to initiate those changes.

Sandra handed out an analysis of the ice for 1st and 2nd session. Reminder to be mindful that if submitting 75min ice, Associations could potentially have a lot of wasted ice by the end of the season if they are only using 60minutes of those slots.

- re: AWG: when teams are formed, Z5 will be asked to provide ice for practices.
- FMC to have 3 ice surfaces available in 2nd session
- EDM is losing their contract at River Cree, and are looking for ice (for home games), from Jan 14th to the end of the season

5. Statistician/Web Report - Rhonda

- Rhonda is keeping track of emails that she needs to send out to Associations. Everything is going fairly well. Goalie play *needs* to be filled out on game sheets. Rhonda will do a sample game sheet and upload to website, to show what needs to be done. She will confirm with RAB, to see if they have a sample available already.

6. Treasurer Report - Jackie

Statement handed out to membership. Not much activity yet

7. Vice President Report - Jackie

8 affiliation issues: 4 were from Associations/teams that came back and said they misunderstood the policy; 4 teams just weren't crossing off players on the game sheet.

Affiliation Policy needs to be understood and followed, as there are fines issued for abusing it.

Questions were raised as to whether or not players should or should not be crossed off the game sheet, in their absence. Brian to talk to RAB and clarify. UPDATE: Affiliates must always be crossed off if not playing, and all

regular players not playing must also be crossed off IF an affiliate is playing.

8. Officials Update (e-mail given to Brian, via Terri/NARRA)

Mentorship program going well.

FMC brought up issue with finding Officials to cover games, when their locals are not available. EDM area officials covering in FMC is very costly due to mileage reimbursement. For this one trip, cost is about \$400, which BGL has covered historically. As FMC is hosting home games in Ft Mac, in the future, they will be responsible for additional expense when using EDM area Officials - per Terri/NARRA.

U14B – FSK not wanting to advance; LAC not wanting to advance (games have been fairly even since 12-3 loss at the beginning of season); FMC ok with whatever is decided. 123 is pushing for 3rd division for provincials. After much discussion, FSK & FMC advance to A – B to stay at one pool
