7. Equipment Facilitator Report

- NEW! Online store was trialed with some success. However, issue with unavailable items, stock changes and refunds prevented us from using it for indoor season.
- Indoor season apparel orders (old school paper forms) are complete and should be in about 4 weeks. 4 jackets on backorder. Suggest looking at other avenues of apparel orders or rethink Adidas apparel as the Adidas stock is the issue.
- Board apparel polo shirts and jackets were purchased for Board Members so they are easily identified at events and tournaments.
- NEW! For coach incentives and thanks for volunteering, each coach was given the opportunity to select a Viking polo shirt or hoodie. This is a way to say thank you to the coaches and have a uniform look on the bench. Plan for outdoor season are T-shirts for the coaches.
- NEW! Agility poles (5 sets) and ladders for training practices. Feedback from coaches was these were a big success. Ordering more so that each field will have a set for outdoor season.
- Looking into getting locker at Fieldhouse to store agility poles and ladders for indoor practices. Keys for coaches.
 - ACTION: Chad will look into the locker at the Fieldhouse.
- Equipment expenses for outdoor season was \$5934.62. Most of that cost was from new soccer balls and agility poles. Indoor season so far, a few hundred dollars for plastic bins, photocopy costs and some ice packs.
- Jersey parents were implemented and it is going well with less damaged jerseys.
