



2018-2019 HPP SOUTH PLAYER COMMITMENT CONTRACT

This Contract is entered into on this _____ day of _____, 2018 between the "Player" and Complete Game Baseball High Performance Program (HPP) South, referred to hereafter as HPP South. The Player and HPP South acknowledge that the mutual promises contained in this contract shall be the full, adequate and complete consideration for this contract and that the term of this contract and all commitments under it shall be for the period extending from October 15, 2018 until March 2, 2019 or the conclusion of the 2018-2019 HPP South term.

During the 2018-2019 HPP South term, the Player shall: 1) primarily participate with HPP South, specifically in priority to any other baseball team or program, including any other Academy team, program, or otherwise; 2) participate with HPP South in priority over any other opportunities, activities, jobs or otherwise; 3) advise Complete Game Baseball, at the earliest opportunity, of any injury that might prevent the Player from participating with HPP South; 4) assist the HPP South with any fundraising HPP South may pursue; 5) and maintain satisfactory grades.

During the 2018-2019 HPP South term, Complete Game Baseball shall: 1) provide 2-3 baseball or baseball-related training or game sessions per week depending on the time of year; 2) will provide an elite speed and power strength and conditioning program; 3) will provide for additional life skills learning and personal development opportunities; 4) will provide post-secondary preparatory services; 5) will assist all individuals who have shown the right characteristics with college placement; 6) and may have direct communication with parents to maintain satisfactory grades.

The above commitments shall in no way prevent the Player from being selected in the amateur draft of Major League Baseball ("MLB") or from signing a contract with any MLB organization or affiliated team. This will also not prevent any player from signing a collegiate letter of intent or playing for their respective provinces or country in any National Championship, or any other international, national or provincial events. The Player will be released from HPP South for tryouts and the summer season for play with their respective minor baseball association programs.

The Player releases Complete Game Baseball, the City of Edmonton, Turf Training Centre, Alpha Conditioning, all employees, volunteers, directors, owners, coaches, consultants, sponsors, donors, independent agents, medical or training staff and generally all individuals associated with Complete Game Baseball and the delivery of HPP South in any manner, from any and all claims or liabilities of any kind or nature whatsoever and howsoever arising.

Upon signing with HPP South, an initial **NON-REFUNDABLE** deposit of \$750.00 + GST will be required. Remaining registration fees of four additional installments of \$500.00 + GST for the following dates: October 15, 2018, November 15, 2018, December 15, 2018 and January 15, 2019 (credit card authorization or post-dated cheques). Alternatively, full payment in the amount of \$2,750.00 + GST may be paid on or before October 15, 2018 (the \$750.00 + GST non-refundable deposit still applies at the time of signing with HPP South as part of the full payment). Credit cards payments are plus a 2.00% administration fee. Cheques are to be made payable to **Complete Game Baseball**.

***Note: If the Player signs a collegiate letter of intent or becomes injured, disabling the Player's ability to participate, before October 15, 2018, the Player is guaranteed a full refund.**
