The Peewee tournament was held in Big Valley and the team did not earn money from this tournament. The team has asked the Big Valley Ag Society for a portion of what was earned to go toward provincials. They are waiting to hear back. Delburne Minor Hockey has paid the \$700 provincial entrance fee. Becky made a motion that Delburne Minor Hockey donates \$500 to the Peewee team for provincials. If the Big Valley Ag Society donates money, that amount will be deducted
- from DMH's donation. Leslie seconded, carried.
 4. Big Valley: Gwen asked Big Valley hockey to schedule a meeting to discuss numbers for the 2016/2017 season. Byemoor will also be included in this meeting.
- 5. Sound System: The Delburne Ag Society is replacing the sound system and Figure Skating is applying for a grant to use toward this.
