10.3.3. The term of one half the Directors shall expire each year. In odd years,

10.3.4. In even years,

10.3.4.2. Vice President Development

10.3.4.4. Three Directors at Large shall be elected for a two year term.

10.4.6. The Vice President Fundamental shall:

10.4.6.1. Supervise all Association teams known as Fundamental for Novice, ~~Initiation and Tom Thumb~~, together with all matters related thereto and to report at all Executive Meetings.

10.4.7. **The Vice President Intro to Hockey shall:**

10.4.7.1 Supervise all Association teams known as Intro to Hockey for Initiation and Tom Thumb, together with all matters related thereto and to report at all Executive Meetings.

10.4.7.2 May serve as a Signing Officer of the Association.

10.4.7.3 Monitor financial affairs for all teams under jurisdiction
