10. New Business

- Constitution
 - o Society Act change redo of our policy's and constitution
 - Made smaller than before
 - o Omit stuff like mail and old wording
 - o 2015 changes that's why out of date not much changed
 - Voted on at AGM
 - o Better defines who member is
 - Qualifications of members defined better
 - o Each family gets one vote
 - o Non-voting & life members are not different
 - Election of officers cleaned, language (director to be paid etc.)
 - President can change any jobs they want or none if they choose
 - o Table officers to be reduced to five
 - Making boards smaller follows the other associations
 - No vote on this stuff
 - Needs to be done for the AGM
 - Need written feedback from board
 - o BC hockey went form 22 table directors to 9
 - Eligible to be voted succession planning no nominations from floor unless they are on the board
 - o 7 days' notice to say they would like to run, small bios provided etc.
 - o Job descriptions also then people can see what the job is
 - \circ B17 75% is now 66% changed
 - o Member until April 15th now clarified
 - o If bi in May then need to be registered
 - New positions Directors (Risk Manager, Assistant Registrar, Ice Allocation)
 - 7 days read constitution. Contact Warren with anything we think is missing or needs to be added
 - John B President picking coach mentors etc. (in policies) may be new wording
 - o Policies are not trying to restate everything
 - We can add on to anything VIAHA but not decrease
 - Finances better wording
 - Ice Allocation not a paid position, takes a lot of time, maybe a change, to be reviewed
 - Policies to be voted on in a month
 - Just a draft
 - o Duties
 - President not changed
 - VP's in order now
 - VP Op coach 2 new added, qualifications, insurance for rinks, ice contracts, signing authority

- VP Admin chair of constitution committee, gets coaching aps etc., signing authority
- Head manager talk to VP OP if any problems need to be addressed
- Treasurer coordination with Registrar, responsible for reports to society branch, qualifications must be met for position, oversees office staff, scholarship committee (heads)
- Registrar clarification on position, payments (rep fees etc.), master wait list, carding done, rosters done all year, communicate within 48hr max time frame, more specific job description
- Secretary nothing changed
- Gaming Director coordinating bottle drives, team applications for raffles etc., rink boards, sponsors, liaises with treasurer
- Risk Manager works with assistant registrar, CATT & everything else (CRC"S, etc.), EPACT (make sure families are registered), injury reports and follow up with families, reviews website for forms etc., primary contact for safety people, reports to VP Admin
- Assistant Registrar annual face to face with registration, doing qualifications for HCR, specific dates set out for HCR & stuff, monitoring HCR's, reports to registrar
- Directors
 - D manager same as before report to head manager
 - Tournament coordinator report to VP op's, change wording for ice contracts, Corinna to email any gaps in job description, coordinate all first tournaments for REP and Rec and hotel accommodations, meet with host teams for running tournaments
 - Website Report to VP admin, look at constitution policies
 - Equipment manager look at policies, inventory etc., bins are a nightmare, yearly report to Treasurer
 - Ref Allocator add monthly report of Refs, allocation report to VP op's, Report for teams have refs per month given to VP OP's, communication to refs regarding clinics, certification, general info etc.
 - Ice Allocator change it to be clearer, take out February, negotiation with facilities, add goalie sessions, ref clinics etc.

- Paid Consultants
 - Look at cons draft
 - Coach mentors change wording for about appointed by president
 - Power skating & dryland instructors include goalie instructor
 - Office admin hasn't changed, look at con draft

- Suspension/Injury Notification
 - o People are not being notified about suspensions
 - o Better reporting systems from admin to div managers needed
 - o Div. managers need to be notified of change in draft of constitution
 - o Safety must be immediate to reports
 - o Send to Div. manager and risk manager
 - Suspensions gross of 3 games and up must notify Harold, 1 game suspensions are not notifies so they are hard to know
