President (Harold Bloomenthal)

VIAHA meeting

BC Hockey rep teams hosted by BCH

Solution is a Passport; this allows player to try out for tier 1 level only at closest association to their home association. If player doesn't make it, they return to their permanent assoc. If they make the tier 1 team, doesn't change associations. Can only try out at one other association. VIAHA President to take it to BC Hockey for approval. This is for Peewee and Bantam. Will report back.

- Provincial hosting opportunity, Bantam Tier 1 and Tier 4.
 - BCH provides funding of \$5000.
 - Deadline is May 15, 2017-05-02
 - Would require letters of support from service providers; JDF and City Center Park re: ice availability
 - Need an organizing committee
 - RIC to confirm if referees are imported or local and confirm we can supply them.
- ePACT medical forms
 - Melissa was able to get about 50% of our members online last year
 - We need to be done with the paper version, and get remaining players online.
 - VIAHA paid \$3/player.
 - Melissa: Will players be allowed on the ice if online forms are not done? Harold: No, but they can fill out the long paper form.
 - A link will be added to the first email sent out to parents.
 - Player's info is stored online and carried forward every year.
- Carryover/suspensions
 - Match penalties will be carried over.
 - Division Managers and Harold let team manager know, who will

enforce. Any issues, Div Manager informed.

- Coach coordinators
 - There are no coach mentors in the North or South Island
 - Bob can't do it due to illness.
 - If anyone knows someone, please let me know
- Atom transition
 - The transition from cross ice to full ice
 - Learn full ice rules, face-offs, offside
 - First six ice sessions will be for this transition
 - We will fast track the transition
 - Further discussions to be had on how this will look
- Officiating
 - VIAHA wording was four officials, forbidden to have two
 - New wording states Bantam and Midget are to have four officials and Atom and Peewee may use three
 - JDF may have problems finding enough officials to have four per game, may need a waiver. Will ask for an exception
- Registrar Sara Blackstock
 - 571 returning players registered
 - o IP1 and IP2 16
 - o IP3 and IP4 78
 - o Atom 126
 - o Peewee 130 Rep 78
 - o Bantam 99 Rep 62
 - Midget 117 Rep 60 Major Midget 24
 - Waitlist:
 - o IP1 and IP2 23
 - IP3 and IP4 13
 - o Atom 4
 - o Peewee 3
 - o Bantam 6
 - IP1 and 2 to be taken off the wait list and accept them
 - We would like to open up registration for another two weeks for parents that may have missed it.
 - Also would like to hold a registration night for new registrations. Sara will set up with Asst Registrar, Trish.
 - Late fees will be waived for late registrations Debra Magnuson
 - The goal is to have no half teams over/under age players may be moved around depending on skill level.

Harold reports on female teams

- Female hockey carries on with all females being on a female team.
 JDF is mandated to have a female team
- Can be duel card, play on both male and female teams, but priority

is female team.

- This will take effect next year, as we have already accepted registration for this year.
- This is a VIAHA policy
- Females can be on a Rep team, tryouts the same as others
- Cannot take two spots, priority is female team, other team they will play as an affiliate
- 12 players to make a team
- Three other associations have teams so there will be games.

- Need to find opportunities for new referees
- Neil Lundin will continue on as RIC for one more year

- A new constitution was adopted at the AGM.
- Job descriptions
 - o Table Officers
 - Experienced, time on the executive, mentoring relationships
 - Respect the reporting procedures, study your job, stay in your lane
 - o Respect each other
 - Share ideas
- Coaching applications
 - o Email sent out to members to submit applications
 - o Work with Murray and Trish
 - o Only those certified on ice or bench
 - o Fingerprints can take 3 6 months to be returned
 - o CRC is good for 3 or 5 years
 - o RIS 5 years, Parent portion tracked by VIAHA
 - o CATT only required one time
 - Check tabs on website for links
 - o 20% of bench staff not certified last year, that is unacceptable.
 - o Charlotte Johnson (VIAHA) will let us know who isn't compliant

Communication/Correspondence

New Business

PCHA

- Harold had a meeting with Kelly Shields, HC
- o PCHA needs sponsorship or letter from a local association.
- Until recently, BCH mail came through JDFMHA, but this is no longer the case, all mail to go directly to PCHA.
- It is advantageous to continue this relationship and have the academy in our community.
- Our agreement with PCHA:
 - PCHA will not interfere with our ice that has been purchased.
 - PCHA agrees to not actively court our players
 - To date, they have had 147 kids go through their program, of those, 10 of them are JDF kids, about 7%
 - Reciprocity from PCHA;
 - \$1000 towards coach mentoring

- Next year it will increase to \$2000
- we do not do their registrations

Motion: Harold to sign the letter, based on information given, to continue to support PCHA

Discussion: PCHA has taken Bantam players out of our program, this decimates our Bantam team.

General consensus: They are still taking our players, but if we don't sign the letter they will find another MHA and we lose any leverage with them. If we find out that they are poaching our players or any other infraction, we won't sign again.
