Financial Report - Treasurer - Terry Phelps

All good. The gaming grant came through of over \$100,000. We have had the expendednture for the new jerses. We are looking good financially. The zone

assessments cost about \$4500. We also received \$10,000 from the City of Langford. Our bank is no longer open on Saturday, as of Oct 1^{st} . Team accounts are all set up and ready to go.

President's report

- I attended a meeting with VIAHA in Nanaimo. BC Hockey program to go paperless is not ready yet. We will continue to use game sheets.
- Ref rates other associations voted on changing their ref rates. Rates fall under VIAHA bylaw. Some associations were trying to vote on changing the rates. It was not passed. A committee was established to find out what other associations pay. Rates will stay the same for the time being.
- Zone program Kerry Park and Sooke went really well. All those that were released felt that they were fairly treated. We kept four or five from other associations for each division. VRC only had players from peninsula coming but didn't get many trying out. Our association and hockey community is to be commended for being so respectful.
- Juveniles. There is only one other on the island, Saanich. We want to be a provincial contender; there is some discussion to integrate to make productive games.
- Midget T2 is vulnerable, having a hard time finding rep players. Currently have 14 players now, have another one coming from Prince George. We will be contacting Laura soon to get him registered.
- Female South Island Presidents met, there are no more girls. Not enough to create an all female league. We agreed between associations to have a team of 23. Some associations have gone back on the deal and now there aren't enough to make a team. JDF has spent approx \$30k in last four years on female program to no avail.
- Chain of command Everyone needs to stay in their own lane. If there is an issue that involves another's portfolio, please go to that person.

Ref clinic to be held $0ct\ 20^{th}$. Last year we had 64 refs at the end of the year, we now have 80.

All rep tournaments are a go. Hotels booked, teams need to make sure their families book. JDF Bantam tourney – full with two on the waitlist.

We have secured tournaments for all 10 IP/Novice teams. 8 are in Saanich, 2 in Cowichan Valley.

There have been some issues with people going around me, we need to work through this. **Equipment Manager** – Equipment is going out. Socks are in, teams are to pick up at my store.

Head Coach/VP Operations – Fairly busy, rep stuff 95% settled struggling with numbers in midget, some returning from junior B, rec assessments happening. Brian has been busy with assessments.

Coaching clinic – Oct 13 – 14, dev 1 clinic.

Coach 2 – hosting near remembrance day before or after.

Mentoring goalies and power skating will happen on a more regular basis.

There is some frustration with PCHA. They are recruiting our players and that is not supposed to be happening. Harold will follow up with PCHA.

Risk Management – 94% compliance of ePact, 638 of 678. 19 have expired, chasing them to get it completed.
