3.0 Old Business

- New jerseys for Rep teams

 - It was noted that both KPMHA coaches who are attending this clinic should be reimbursed (ie. Karl Faber and Chris Claxton)
 - There was discussion around the timing of payment in the past, coaches who have taken Development I have been reimbursed at season end, once the post task has been completed. Considering the length of this Development II program, and the travel required to attend the clinic, the executive felt that reimbursing the coaches now would be better.

- Development Ice Update
 - Rick presented the information that Wayne compiled regarding the development ice plans for the upcoming season
 - \circ Background info on the planned development program for the upcoming season
 - The rep coaches met with each other and with Jeff Compton to discuss the idea of having a year-long program run by Jeff Compton for the players of KPMHA
 - The rep coaches also came up with the idea of running a "rep-prep" type camp this summer
 - It was stressed that this is not tryout related
 - There will be no parent involvement except for the coaches
 - The Midget Female Rep team has two co-coaches who have stepped up for next season – Dan Little and Doug Robb – these coaches will be involved with the rep-prep camp as well
 - Wayne has put forward some ideas for mid-season development ice as well
 - Pro-D days and stat holidays were mentioned as being possible dates to run specific development programs
 - Gold in the Net
 - Battle Camp
 - Shooting Clinics
 - Wayne suggested that we need to have the executive commit to development programs early on this season, in order to be able to better plan and book these programs
 - Wayne has put an RPF forward to Compton Sports, based on a two-stage process

- Stage One
 - One time expense
 - Development of coaching packages for both recreational coaches and rep coaches
 - These packages would be given to the coaches at the beginning of the season, and would include things such as: practice plans, tips on how to better coach, etc.
 - KPMHA would add their own information to this package ie. parent/player contracts etc.
- Stage Two
 - Long term development
 - Compton Sports would monitor and give feedback to the coaches over the season
 - This would be for both recreational and rep coaches
 - The goal is to get better development for the coaches, who can in turn, better develop the players
- We are waiting on a cost estimate from Compton Sports at the moment
- Lyn pointed out that the rep coaches developed this model for themselves at their earlier meeting
- Rick suggested that most competitive MHA's have paid head coaches Saanich, JDF, Racquet Club, Nanaimo, Victoria, Campbell River, etc
- Jeremy noted that most MHA's are now reaching out beyond their executive/membership for help with their development programs
- Louise wanted to know the cost, and thinks that the idea sounds good, but is concerned about the cost
- Rick mentioned that this is an idea that Tom had been batting around for +/- 2 years
- Allan likes the idea of developing coaches to develop the players
- Rick noted that there would likely be a very small time commitment for the coaches (maybe one hour per month)
- Lyn will look into applying for/hosting some Hockey Canada development clinics
- Cam expressed concern over the possibility of creating a two-tiered cost system, one for rec, and one for rep
- Rick noted that for this season, the money for this program would come from last year's surplus, which is also being spent on new jerseys. Next season, KPMHA could look at other options to continue funding this development program.
- Proposed Tryout Schedule
 - Tom noted that there is a problem with having the tryouts starting on Sunday morning, and would like to see the tryouts bumped down to later that afternoon
 - Wayne will connect with Sheena to see if we can swap times with the Jr.B team, and possibly get five sessions on the Sunday, so that every group of players trying out has an opportunity to be on the ice on Sunday

- Midget Female Rep team
 - An AP issue around the girls' teams was brought up. Players can only be AP'd from the association that is hosting that team, ie. only KPMHA female rec players can be AP'd to play on the KPMHA Female Rep team, no female rec players from CVMHA are allowed to be AP'd under the existing system.
 - A possible solution that was suggested is that all female rec and rep teams could be carded out of KPMHA, but play out of both KPMHA & CVMHA arenas.
 - This would not affect our MHA tiering status, as female players are not included in that calculation
 - \circ $\:$ Much discussion was held around where to host the female teams, KPMHA or CVMHA $\:$
 - For the moment, KPMHA will get the extra ice for the female team
- Atom & Peewee B Teams
 - If KPMHA hosts both an "A" and "B" team in the Atom & Peewee divisions, we will need to buy more ice at Lake Cowichan
 - $\circ~$ If KPMHA does not host these "B" teams, or hosts only one of these "B" teams, we have enough ice as is
 - There was much discussion around whether or not to host these "B" teams, including:
 - Coaching concern who will coach the teams
 - Team sizes could be a concern
 - Can the "B" teams have more ice than a house team, but less than an "A" team
 - Possibility of sending the bantam female rec players to CVMHA to free up more ice at KPMHA
 - Lyn noted that the coach of the Peewee rep team did not see the depth with having a Peewee B team
 - Mike Martin suggested that Rick Pipes and Rob Webb be consulted regarding the Pewee rep teams

Motion:

To register an Atom "B" and a Peewee "B" team with a modified practice schedule, if required;

To have four teams in each of the Atom and Peewee divisions;

To acquire 3 hours of additional ice per week from Lake Cowichan.

5.0 President's Report

- Jeremy would like to see a sub-committee formed to put together terms of reference for a "Merit Fund" proposal Rick will draft with assistance from Louise
- Jeremy & Tara attended the VIAHA AGM
 - The meeting minutes are posted on the VIAHA website
 - Mark Kenney has remained in the position of President
 - A detailed discussion regarding carding teams and amalgamation was held between Joe McDonald, Jeremy, and Tara

- Amalgamation can only be 100% of an association (not only rec or rep players)
- CVMHA would have to make application to KPMHA, then to BCH, only if KPMHA supported it, then a vote by the membership would have to take place at KPMHA to dissolve the society
- There was a motivational speaker at the VIAHA AGM who may be a good fit for a presentation to the Bantam & Midget aged players of KPMHA and CVMHA
- The competitive coaches have had 2 meetings to date, with one more planned for next week
- The Presidents, 1st, and 2nd Vice Presidents of KPMHA and CVMHA met on June 15th on Jeremy's porch.
 - CVMHA is definitely not interested in pursuing amalgamation with KPMHA at this time (ie. for the upcoming season). There will be continuing discussion at KPMHA as per the amalgamation survey results from the membership.
 - If either MHA has no team in category, those players will be transferred to their adjoining MHA.
 - There was discussion regarding collaboration on development camps, etc.
 - \circ $\,$ There was an expression of mutual respect and support for the carded teams in each MHA.
 - The lines of communication between MHA's were reviewed CVMHA requested that individuals not contact CVMHA directly, but rather forward their communications through their respective Presidents.
- Erin has confirmed with Jeremy that we have received grant approval from BC Gaming, but the amount has not been determined yet.
- A request of collar & tie attire for the competitive coaches has been put forward by a parent.
- Barb Norton is hosting a meeting of the South Island Presidents tomorrow night the agenda is available for review.
- The Atom C3 team manager has not paid the rental bill that is owing from last season. This member will again be a member in bad standing, until the invoice is paid in full. If a transfer request for her children comes through the HCR, the request will be denied until the invoice is paid. Tara will communicate with this parent on the matter.
- Goaltender Release Request
 - Much discussion took place regarding the possible release of a goaltender to CVMHA for the upcoming season
