TOYOTA TACOMA RAFFLE 2017 TRUCK RAFFLE RULES, AGLC License # 467585

- 1. Raffle tickets shall not be sold to any person under 18 years of age.
- 2. Purchasers shall be advised not to write the name of a person under 18 years of age on any ticket.
- 3. If a winning ticket bears the name of a person under 18 years of age, AGLC regulations governing such matters shall apply.
- 4. Tickets shall only be offered for sale within the Province of Alberta.
- 5. A purchaser and/or winner does not have to be a resident of Alberta, provided they were present in the Province of Alberta at the time of purchasing the ticket. (Example: A visitor to Alberta who purchases a ticket at a local display within the Province.)
- 6. If a winning ticket bears the name of more than one person, the Society shall award the prize to only one of those persons named, and neither the Society nor the AGLC shall be responsible for any disputes that may arise between the different individuals whose names appear on the ticket stub.
- 7. Only the Raffle Chairperson and the two designated members of the Association's Executive Board of Directors who will take part in conducting the draws, shall be prohibited from purchasing tickets. All other persons meeting the aforesaid criteria shall be permitted to purchase tickets.
- 8. If a minimum of 4,600 tickets is not sold before November 30, 2017, the draw date may be extended or the raffle cancelled. If the raffle is cancelled, the purchasers will receive full ticket price refunds.
- 9. All Prize Draws will be held at Country Hills Toyota, 20 Freeport Landing NE, Calgary, Alberta. All prize draws will be open to the general public. The exact time of each draw will be posted on the Association website in advance of the draw dates.
- 10. All draws will be conducted in strict accordance with Alberta Gaming Regulations.
- 11. All ticket orders received and fully processed by 5:00 pm on the day prior to the draw shall be eligible for that draw. Any ticket orders not arriving in sufficient time for the draws shall be fully refunded and returned to the person placing the order.

- 12. Retail value of all prizes is \$47,000.00. Only 20,000 tickets will be sold at \$10.00 each. Three prizes will be awarded: Grand Prize 2017 4x4 Toyota Tacoma, valued at approximately \$45, 000.00. 2nd Prize Draw is 1,500.00 Cash. 3rd Prize Draw is 500.00 Cash.
- 13. There shall be no options for 'Cash in Lieu' for any prizing within this raffle, and prize must be accepted as is, where is. Any cost associated with transporting the Grand Prize, the 2017 4x4 Toyota Tacoma, to another location shall be the responsibility of the winner. The only warranties or guarantees shall be those provided by the manufacturer with respect to the 2017 4x4 Toyota Tacoma, which is brand new and shall bear only such mileage as necessary to move it from one display location to another during the raffle.
- 14. Draw date for Final Draw Saturday, December 16, 2017. Tickets drawn this day shall be considered the winner of the 2017 4x4 Toyota Tacoma, 1,500.00 Cash and 500.00 Cash. Three separate tickets will be drawn for these prizes. The order of these Draws will be done as follows: 1st Draw will be the Grand Prize 2017 4x4 Toyota Tacoma. 2nd Draw will be \$1,500.00 Cash. 3rd Draw will be \$500.00 Cash. Winning Tickets will not be re-entered into the 2nd and 3rd prize draws.
- 15. All reasonable measures will be taken to contact the winners immediately following the draws, including posting the winning ticket information on the Association's official website. If, after one full year, a winner has not come forward to claim their prize despite all reasonable methods to contact them being exhausted the Association shall apply to the AGLC to have the value of any unclaimed prize(s) accrue to their own charitable purposes, upon AGLC approval.
- 16. Once a ticket order has been received with appropriate payment, and the order processed, it becomes a non-refundable transaction, except in the unlikely situation where the raffle as a whole has been cancelled.
- 17. Once a ticket has been purchased, no refund will be issued.
