- 3.1 Constitution Amendments

Draft proposal circulated by Brenda Rowe. Points discussed:

Part 2 – Membership. 2.3 & 2.4 Discussion around membership. Conclusion:

Membership to be one vote per playing member and that the voting name is to be put forward at the time of annual registration – that the designated person can only be changed at the time of registration.

Membership will also be extended to individuals who are not able to be a member under part (a) who have an active role with the SCMHA. These individuals will register their membership annually with the SCMHA.

TASK: Stu to "wordsmith" the constitution as it relates to membership to cover the intended "definition" as described above. To be shared with board members prior to the November 26, 2017 Special General Meeting.

Part 3 – Meeting of Members. 3.7 Discussion around annual general meeting dates. Conclusion: Subject to the Societies Act, the annual general meeting shall be held in May at such time and place as the Directors may determine by resolution.

The number of directors shall be an odd number of no less than seven and no more than thirteen.

Discussion regarding the roles and titles of directors as elected at the AGM. Conclusion:

As circulated: Directors shall be elected to the positions of President, Vice President, Secretary, Treasurer, Registrar. The balance of the Directors shall be elected to portfolios as decided on by the Board, and communicated to the membership prior to the Annual General Meeting at which they will be elected.
