Late in the year the bantam league ran into suspension issues with a number of players. In all six players from various teams ended up with suspensions which were reported to me.

The suspensions that I gave out were heavier than the minimums set out in the SHA handbook. The reason being is when I received a report from a referee on an infraction, I took it very seriously as the potential for serious injury was there. In fact one report had a player being taken to the hospital and when I saw this report, I suspended the offending player indefinitely pending a report from the injured player's doctor. Fortunately the player was not seriously hurt or I would have suspended the player for as long as it took the injured player to recover. I have zero tolerance for major penalties that are the result of a hit to the head, checking from behind, boarding, charging etc...

I have been involved in minor hockey for 40 years and just want to ensure all players can feel safe playing the game. Players that don't respect their fellow players are not good for the game and if they want to continue to play them game must learn to control their actions.
