AMENDED 2017

6 (a)Postponement or rescheduling of scheduled league games, except in the case of adverse weather conditions are subject to the following conditions:

- 1. The postponement must be agreed to by both teams. If no agreement is reached the game will be played as scheduled.
- 2. Postponed game shall be rescheduled at a mutually agreed date and time.
- 3. The Division Commissioner and Web Site Administrator must be immediately notified of the postponement and advised of the new game time.
- 4. Disagreement regarding postponement or rescheduling may be appealed to the Division Commissioner. The following reasons will not be considered:
 - a) Attendance at an exhibition game or tournament.
 - b) Lack of players for any reason, unless less than 6 players are available.
- 6 (b) In case of postponement due to adverse weather, the game shall be rescheduled to a mutually agreed date and time. If agreement cannot be reached the Division Commissioner shall direct the time date and place for the game. The decision of the Division Commissioner is final.
- 6 (c) A team not appearing for a scheduled or rescheduled game shall forfeit the game with a recorded score of

7 to 0. If the offending team is the visiting team they shall pay the cost of ice and officials to the home team. Failure to pay will result in immediate suspension and forfeiture of all scheduled games until the debt is paid.

3.Members:

a) Member is defined as a Hockey Association that has been accepted to the SSHL. This will be understood throughout the document.

b) The League as it presently stands shall consist of Shaunavon, Maple Creek, Gull Lake, Cabri, Frontier, Swift Current, Herbert, Fox Valley, Gravelbourg, Glentworth, Ponteix, Kincaid, Assiniboia, and Lafleche.

Hockey Associations willing to comply with and abide by the Rules and regulations of the League may, upon payment of \$50.00 membership fee and make application to join the League. Such application to be voted on and the team accepted by a majority vote of the members in good standing at the Fall Meeting.

c) Leave of absence may be granted when applied for by any member.

d) No Tiered or leveled teams allowed to play in the SSHL except a 15 year old team playing out of any center of the SSHL, but cannot be "AP" to any SSHL team in the Midget League. If your center only has one (1) team registered at that level you can register a ghost team for the purposes of "AP" only.
