a) Registration Update

b) Team Declaration for BGL

We are currently looking at: U10 has 7 teams with 14 players each. U12 has 5 teams tiered A,B,B,C,C. U14 has 4 teams tiered AA,A,B,B. U16 has 3 teams tiered AA,A,B U19 has 2 teams tiered A,B

SGRA is approaching capacity for players per team for U10. We may potentially have 8 U10 teams to avoid having 15 players to a team. The board recommends that the oversight committee investigates, speaks with Lynda Snider and then decide the teams and levels.

The Ramp App is similar to Team Snap. It is \$25 a team this year but will be \$50 a team next year instead of \$35 if we don't use it association wide this year.

Motion:

Rhonda Kew moved that SGRA will fund Ramp Team App for the 2017/18 season up to a \$600 total. Shelley MacCullum seconded. 11 in favor, 0 opposed. **Motion carried.**

Jerseys are a mess in lockup We will be changing locks every year for the storage locker in the future.

We have received 2 extra bingos for a total of 16. Ivolunteer is approaching its maximum limit so we need to look into purging the data base.

Heather Murray will call AGLC regarding casino.

Chantal Mackenzie needs the registration list with the player names and levels. Beer Shak will continue donating 5% of purchases to SGRA when customers say they are purchasing with SGRA.

The Agrena has hot water coming out of fountains.

We will hold a debriefing of our evaluation process in October.

Leanne Couves would like to use a facilitator to create a long term and 3-year plan for SGRA.
