7.2.1- Preseason starts 1 week earlier this year, September 4th. Teams will be finalized by September 28th. Teams must be submitted to CALL by October 5th, to avoid fines.

7.2.2- Val Norrie power skating for Novice- Val Norrie likely can only accommodate Novice power skating on Saturday mornings. 3 or 4 hours of sessions would be needed in order to secure her services.

7.2.3- ATC Goaltender Camp Proposal- Base Camp Cost, \$3000; travel, accommodation, meals to be covered by host MHA. Additional Group Cost (covers additional 12 goalies, if needed.), \$1200.

Brad Robbins made a motion for SMHA to cover the base camp cost of \$3000 to host an ATC Goaltender Camp, tentatively scheduled for September 8-9, 2018. The remainder of associated costs above will be covered by charging SMHA registered goaltenders a fee of \$100 and non SMHA registered goaltenders a fee of \$200 to attend. Jerilyne Raab seconded the motion. All in favour. Motion carried.

Brad Robbins made a motion for SMHA to cover the cost of \$865 to host Method Hockey, for classroom and on ice coach development, date to be determined. Brett Nixon seconded the motion. All in favour. Motion carried.

Hockey Alberta decision to phase in Novice half-ice this year, with MHA's being allowed to run some half-ice and some full-ice. HA guidelines recommend half-ice for 1st years, and some full ice for 2nd years, or "like skilled".



CALL is in the process of creating Novice divisions. MHA's seem to be mixed on how they will proceed with their Novice divisions this season, with some deciding to run full-ice and some running half-ice.

Recommendation for this transition season, SMHA has 1 Novice (travel) team join a Novice division in a league (to be determined), in order to secure games. The remaining SMHA Novice teams would play house league, following our current established model.

Discussed pro and cons related to a Novice travel team. Final decision will be made after registration numbers are finalized. 1 travel team would only be possible if there are adequate registration numbers in Novice.
