5) New Business:

- **5.2 Referee Allocator** Past ref allocator has moved away, need a new one. Suggested teams to pay this position more, allocator may ask for more. Char motioned to advertise for position, Joanne McMahon second.
- **5.3 Battle River Representative** Initiation and Novice team are expected to communicate with Battle river league. In the past this has not been a smooth or effective communication. It was suggested that the Castor Recreation Director could be communicated with.
- 5.4 Coach applications to be submitted by September 8, 2017. Paris to place on website
- 5.5 Bottle Drive Organizers Dayland Shaunet Petiot; Forestburg Char Curtis
- 5.6 Hockey Dues for 17/18 season not being raised.

6) Other Business/Additions:

- **6.1 Provincials** will bid for provincials this year after we see how our teams are doing. Good money maker.
- **6.2** Maureen will be stepping down as Casino Chairperson. Joanne will take over organizing shifts when our casino time comes up.
- **6.3** Banners for 2 arenas Joanne brought up that when a team wins a tier/League banner one is presented. If a team goes to Provincials it is often expected that the team brings and pays for a banner. Joanne moved that the TMHA pays for the provincial banner and a second League banner for a team to display at second arena. Robert second. 15 voted yes, 1 voted no.
- **6.4 Player Evaluations** Parent inquiring about Child evaluations when 2 teams need to be chosen in an age group. Discussion was held about the process; 2 volunteers from each town (who do not

have kids in age group and often don't have kids in hockey, but have hockey experience themselves). Evaluators only have a list of the numbers and colors of jerseys – no names to keep their evaluations impartial. The coaches are occasionally included in the final decision if it is difficult to choose the last few kids that could go on either team. Letters are drafted up and handed out or emailed to children/families on the last night of evaluations. The question from the concerned parent was why doesn't the parent or child get to see where they were on the evaluation "list". No other associations in our area shows the child or parent where their child placed as a number, this will not help the child and will likely cause more grief, confusion and stress about where they fit on the team. Evaluators may not want to volunteer their time if they will get harassed by parents about how they placed the children in number succession. Suggestion was to edit the evaluation form to have a comments section about what a child could work on to better themselves. A board member that doesn't have a child on the team and team contact to be on hand for evaluations. Char to edit form.
