TOURNAMENT SANCTION

POLICY AND PROCEDURES

Approved: 13 November, 2007

1.0 INTRODUCTION

The Association must seek approval from Hockey NWT for any tournament which involves players from another association.

2.0 APPLICATION PROCESS

- The Association must submit a Request for Tournament Sanction, by fax, to the Hockey NWT Registrar, at least four weeks prior to the tournament.
- The Association must then submit the original application with a cheque (made payable to Hockey NWT) for the Tournament Sanction Fee of \$30 to the Registrar Hockey NWT. The fee applies to each division, if the Association is hosting a multi-division tournament.
- The Hockey NWT Registrar will fax the approved application to the Chair, Special Events Committee at least three weeks prior to the start of the tournament.

3.0 TOURNAMENTS

- The relevant governor must ensure that only players on the Hockey NWT Registrar's approved team lists participate in the tournament.
- The Referee-in-Chief for the tournament must be provided with a copy of the Registrar's approved team lists.
- A Tournament Sanction Permit entitles the host Association to obtain Hockey Canada certified on-ice
 officials. Without a permit, the Association is not entitled to use certified on-ice officials.

4.0 SANCTIONS

- Any player, coach or other team personnel who participate in a game, when not registered with Hockey NWT revokes the insurance coverage of all participants and voids the Tournament Sanction Permit.
- If the Association allows players, coaches or other team personnel to participate in a game, when not registered with the Association and on the Hockey NWT Registrar's team list, it could be subject to disciplinary action by Hockey NWT.
