For the 2016-2017 seasons I agree to the following conditions:

- 1) I must act with integrity in performing all duties owed to the athletes, the sport, other members of the coaching profession, and the public.
- 2) I must maintain the highest standards of personal conduct and support the principles of fair play.
- 3) I must act in the best interest of the athlete's development as a whole person.
- 4) I, the coach take full responsibility for all rules as set out by Yorktown Minor Hockey, SHA and CHA.
- 5) I will treat everyone fairly within the context of their activities, regardless of gender, place of origin, color, sexual orientation, religion, political belief or economic status.
- 6) I will direct comments or criticism at the performance rather than the athlete.
- 7) I will consistently display high personal standards and project a favorable image of the sport and coaching.
 - Refrain from public criticism of fellow coaches, athletes, officials and volunteers, especially when speaking to the media or recruiting athletes.
 - Abstain from the use of tobacco products while in the presence of her/his athletes.
 - Abstain from drinking alcoholic beverages when working with athletes
 - Discourage the use of alcohol in conjunction with athletic events or victory celebrations at playing site
 - Refrain from the use of profane, insulting, harassing or otherwise offensive language in the conduct of my duties.
- 8) I will ensure that the activities being undertaken are suitable for the age, experience, ability and fitness level of the athletes and educate the athletes as to their responsibilities in contributing to a safe environment.
- 9) I will communicate and co-operate with the registered medical practitioners in the diagnoses, treatment and management of the athlete's medical and psychological problems. Consider the athletes' future health and wellbeing as foremost when making decisions regarding an injured athletes' ability to continue playing or training.

- 10) I will recognize and accept when to refer athletes to other coaches or sport specialists. Allow athletes' goals to take precedence over your own.
- 11) I will regularly seek ways of increasing professional development and self-awareness.
- 12) I will treat opponents and officials with due respect both in victory and defeat and encourage athletes to act accordingly. Actively encourage athletes to uphold the rules of their sport and the spirit of such rules.
- 13) In the case of minors, I will communicate and co-operate with the athlete's parents or legal guardians, involving them in management discussions pertaining to their child's development.
- 14) I am aware of the many pressures placed on athletes as they strive to balance the physical, mental and spiritual aspects of their lives and conduct practices and games in a manner so as to allow optimum success.
- 15) Coaches Must:
 - Ensure the safety of the athletes with whom they work
 - At no time become intimately and/or sexually involved with their athletes. This includes requests for sexual favors or threat of reprisal for the rejection of such requests.
 - Respect athlete's dignity; verbal or physical behaviors that constitute harassment or abuse are unacceptable.
 - Never advocate or condone the use of drugs or other banned performance enhancing substances
 - Never provide under age athletes with alcohol, never encourage its use.
