

### **GUIDELINES OVERVIEW**

The Basketball Nova Scotia (BNS) **Standard Misconduct Penalty Guidelines** is an important piece of the organization's Discipline Policy, designed to uphold the integrity and spirit of competition within our sport. It is also governed by Safe Sport principles, grounded in the emphasis on safety, fairness, and mutual respect amongst all participants.

These guidelines outline a structured and cumulative approach to managing misconduct, ensuring consistent and fair consequences for infractions at all levels of play. By adhering to this chart, all those involved in the game of basketball can be assured of a system that is committed to long-term growth and success. Please note that the system is cumulative in nature, meaning that any disciplinary actions, including suspensions, will carry over into subsequent seasons if the stipulated time or number of games remains unserved.

BNS believes this approach will foster a positive and respectful environment, encouraging all athletes, coaches, officials, administrators, and spectators to uphold the highest standards of the game.

# STANDARD MISCONDUCT PENALTY GUIDELINES

**IMPORTANT NOTE:** Basketball Nova Scotia (BNS), through its Discipline Panel, shall have authority to suspend or otherwise penalize any athlete, coach, member or spectator for misconduct associated with these guidelines, in addition to any violations of BNS's Code of Conduct & Ethics policy. Where the misconduct or violation is not fully prescribed, the period of suspension or other penalty shall be left to the discretion of BNS.

Members are also encouraged to review the **Serving Sanctions** section of the Discipline & Complaints Policy.

## **DEFINITIONS:**

#### Abuse - Verbal

Verbal abuse is a means to dimmish or intimidate using, but not limited to, some of the following forms:

- Slandering, ridiculing, bullying, gossiping, or defaming someone.
- Persistent name calling, which is hurtful, insulting, or embarrassing.
- Chronic teasing, belittlement, or frequent criticism that undermines the victim's ability to perform.

#### Abuse - Nonverbal

Non-verbal abuse can be an act or gesture including but not limited to:

- Threatening gestures, actions, or glances.
- Shunning, excluding, or disregarding a person.
- Offensive depictions of another through a visual medium such as a drawing.

Mimicking another in an offensive manner.

**Code of Conduct & Ethics** is a BNS policy and guiding principle that defines the rules around expected behaviour at all times, aligning with BNS's core values, mission and policies.

Discipline Panel refers to a group of individuals appointed to oversee discipline processes and decisions as indicated by policy.

Game officials are referees assigned to officiate a basketball game.

**Ejection** is the act of removing a player or coach from the game by a referee for serious offenses, such as accumulating two technical fouls, committing a flagrant foul, or engaging in a fight or other serious unsportsmanlike conduct.

Falsified Information means providing information that is not correct or in the attempt to mislead.

Flagrant Act or Foul is unnecessary or excessive contact that could result in injury to a player, as determined by the referees.

Ineligible Player means an athlete not qualified to participate.

Intentional Contact is a deliberate physical action or touch that is performed with a specific purpose or awareness of causing that contact.

Objectionable Behaviour is action or conduct that is considered offensive, inappropriate, and/or unacceptable.

**Player** refers to an individual who is an athlete participant and therefore subjected to the policies of Basketball Nova Scotia and to the Code of Conduct and Ethics.

**Safe Sport Policies** are regulations and codes of conduct designed to create and preserve a sport environment that is physically, psychologically, emotionally, and culturally productive, positive, and safe for all participants.

**Sanctioning** means the infraction or penalty related to an action.

Season means the BNS designated seasons including Fall/Winter: September 1-April 30; and Spring/Summer: May 1-August 31.

**Seasonal Offence** includes infractions or discipline within the same season.

**Spitting** means the intent to eject saliva forcibly from one's mouth in a gesture of contempt, anger or frustration.

Standard Misconduct Penalty Guidelines lists the sanctions involved with misconduct related to players, team staff and spectators.

<b>Team Staff</b> refers to any coach, trainer, manager, agent, team staff, official, medical, paramedical personnel, parent, or any other person working with, treating or assisting an Athlete participating in or preparing for sports competition.
