iv. Ringette Calgary Update

- Chinook Ringette League (CRL) is looking at the scheduling challenges this past season, such as the Session 3 / Playdowns format. There was discussion around the impact of exhibition games on scheduling and refs during the end of the season and whether these games should be low priority to alleviate the scheduling issues. Cheryl shared our concern that given the month or longer break between provincials and post-provincial championships for those advancing to WCRCs / CRCs, the exhibition games are actually very important.
- Ringette Calgary / CRL retreat on Apr 22 was productive and came away with some clarity on Ringette Calgary and CRL roles
- CRL originally intended to be a 1 year transition to become a stand-alone entity, however it was determined that a 5 year timeline would be more realistic. Also need to engage Zone 1 and Zone 2 representatives to join CRL as all three zones are participants.
- Also noted that Seven Chiefs will not renew the Ringette Calgary ice contract for next season.
 They are currently exploring other ice acquisition options.

v. RAB Update

- RAB's AGM is next weekend on May 6/7 in Red Deer; Cheryl B, Michelle B, and Becky S will attend as our AA reps.
- RAB announced recently that the Alberta Winter Games 2024 will be a U16A/B event only. AA
 players are not eligible to try out. Coaches please note: Any coaches who aspire to one day
 coach at the CWG level must have coached at the AWG level, so please watch for AWG
 coaching info.

b) <u>VP League</u> (Heather H.)

- i. Currently working on RFPs for U14 dryland providers, and player development sessions (nutrition, mental training) for next fall
- ii. Committee updates:
 - Ice Allocator (Cristina / Annette)
 - Booked ice for the Intro AA skate
 - Booked ice for the fall tryouts based on previous numbers as a guide
 - Ring It On ice confirmed with Great Plains that we want the same as last year
 - Working on securing ice for the fall to support what we receive from Ringette Calgary ice pool
 - Cristina, Annette and Heather will be our reps for calling in to the Calgary City ice booking session for fall ice group purchasing on May 5th
 - Exploring an ice contract with Lake Bonavista
 - Please contact Cristina or Annette if you have any other connections or contacts for possible ice contracts
 - Questions raised around why AA doesn't have regular ice schedules for teams, why
 teams are required to fundraise so much to purchase their own extra ice, and why
 AA registration fees don't cover all the ice we need like at other associations.
 Discussion on challenges of AA ice scheduling and contacts:
 - Since we are an entity of Ringette Calgary, they support us in securing ice.
 They have ice contracts, of which we receive an allocation for practices, and they pool ice from all the associations to assign league game schedules.
 - We let them know our desired ice budget, although due to increased ice costs this year we received less practice ice than usual for the same budget.
 - We assign teams to practice ice that we receive from the Ringette Calgary ice pool. We often do get some regular times/locations but they are split among the teams. Then teams will decide if they want to purchase any extra ice that suits their specific needs and schedules.



- We are exploring our own ice contracts to assist with equalizing ice for our teams, however it is difficult for us to establish regular ongoing ice contracts since our teams have individualized schedules (ie. social events, dryland nights) and often several teams are away at tournaments leaving us with a lot of unusable ice that we need to try to sell to associations.
- It was also noted that registration fees at other associations don't cover their full costs either. Other associations must fundraise to cover their full costs (casino, pub nights, raffles, sponsors, tournaments, etc).

 - Equipment drop off scheduled for May 4th; info was sent to teams
 - Sewing Contacts reminder to let us know if your team has a sewing contact that
 they use; we will compile a list of resources for sending teams for sewing name bars
 or getting repairs to jerseys, pants
 - Will be purchasing supplies for the medical bags for next season soon
 - Please let Greg know when the Coach meeting will be in August so the medical bags and other supplies are distributed at that time.

c) <u>VP Operations</u> (Colin/Aaron)

- i. Committee updates:
 - Banquet Coordinator (Kristy / Brian / Stephanie / Angela / Michelle M.)
 - Banquet is tomorrow night
 - Everything is set, with just a few décor projects to finish up
 - All volunteer spots full
 - Awards (Holly)
 - Nominations are closed and awards have been determined
 - Will be announced at banquet tomorrow night
 - AA Intro Spring Skate (Brad T.)
 - Sessions are set for May 1 and 3 next week
 - 47 players have registered which basically gives us 2 full ice times; only one goalie signed up which may be a concern to watch for this fall and ensure we promote goalie recruitment for tryouts
 - 4 skaters from U14AA are recruited to help as well as several U19AA to run the ice sessions



- Thank you to our ice, website, social media and registration volunteers for your help with this event!
- Provincial Tournament (Kristy)
 - Still waiting on kick back funds from three hotels (approx \$1200)
- Social Media (Brad K.)
 - Aaron: thank you to Brad K for his work on our social media this season and doing a great job to increase our profile
- Website Development (Brad M.)
 - Aaron: thank you to Mike L for his work this season and over the years on our website and supporting the transition to the new website.
 - Aaron: thank you to Brad M for his work on transitioning to our new website and the work to maintain
 - Lots of work in the next few weeks to transfer this year into the Past Seasons section and set up new clean pages for next season's teams (website, Flickr, etc)
- Teamwear & Logo (Jenny / Erika)
 - Erika proposing that we get ahead of the order delays in the fall and pre-order some items this summer for next season. Pants in particular take a long time so pre-ordering to arrive in summer is recommended by the Ringette Store; bags are also recommended; need to check in with Jenny on how the pre-ordering and payment for that order has been done in the past
 - Discussion around whether U14s should buy red and blue pants since they are
 wearing out the borrowed blue pants too quickly by wearing them at practices
 instead of just the occasional game when needed. Season-end surveys so far
 indicate that apparel costs are not unreasonable so this info suggests we could
 move to them buying blue pants. Alternatively we could have a jersey / blue pants
 parent that keeps them to prevent over use.
 - Erika to investigate and bring info back for board; AA has funds to front the order
- Tournament Coordinator (Wendy / Kristy)
 - Discussion on possibly not sending teams to Saskatoon next season and asking for
 2 spots in Regina instead, or possibly run a local "Hub" weekend instead
 - Kristy to connect with Wendy to learn more about the role
- Registrar (Amanda)
 - Tryout Registration: proposing our tryout registration will open June 1 to June 30 for \$100 early bird; July 1-Aug 15 for \$175 regular; Aug 16-24 for \$350 late
 - Need to be sure we can manage any late registrations in terms of numbers and planning the tryout rosters / ice needs; 90% register in early bird period so we have time to adjust for buffer space if needed
 - Aug 28 tryouts begin; the Aug 24 cut off date gives us time to prepare
 - Motion to approve the Tryout Registration package dates and fees as proposed, made by Dave Patton, seconded by Cristina M. Motion carried.
 - Season Registration: proposing to keep our registration fees at \$1200 per player upon being drafted to a team for the 2023/24 season



- Question was raised to clarify what the registration fees actually cover since AA also pulls funds from teams during the season, which was a new approach for some families.
 - o VP Finance explained that the registration fees generally cover the costs of early season ice and first-half tournaments.
 - There are other costs over and above what is covered by the initial registration fees (ie. more ice, ref fees, coach courses, equipment and other items).
 - o AA is generally invoiced for \$16K per team in ice; if teams want more than that they can secure it as they see fit.
 - Ice costs and ref costs are pulled from teams twice per year (halfway and year end); other costs are trued up at the end of the season and pulled from team accounts or refunded back
 - Recommendation to update the sample team budgets, especially for U14
- Need to be transparent that the registration fees don't cover the entire
 AA program costs; the fees are not the all-in cost; team fundraising / cash
 calls typically cover at least another \$1000-\$2000 per player for ice,
 social, dryland, team wear, etc depending on each team's schedule
- It was noted that this information was presented in our budget at each
 meeting and regular updates were sent to team treasurers. It was also
 shared at the start of the season at the Manager / Treasurer meeting,
 although we recognize that meeting is overwhelming with info.
- We will need to also outline that the Jersey deposit that previously was returned to team budgets will now be a Jersey fund to be saved for replacement costs.
- Discussion around whether we should charge higher registration fees upfront rather than pull money from teams during the year. Group agreed that spreading costs across the year is more manageable for families rather than setting fees too high in September which is already a heavy month for school and other activity fees.
- Motion to set Registration Fees at \$1200 per player for the 2023/24 season, made by Amanda Roach, seconded by Cristina Mutiso. Motion carried.
- RAMP has the option to accept EFT; giving our registrations this option could significantly reduce our credit card fees; Amanda to look into it
- Manager Mentor (Jenny) not in attendance, no report
- Team Photos (Angie / Angela) nothing to report
- RIO Tournament Committee (Paul B. / Kevin) not in attendance, no report

- i. Financial update
