### Credit Card Pre-Authorization Form

\_\_\_\_ **Jersey Deposit** - I authorize the Elk Point Minor Ball Club to **charge \$100 to my credit card if I fail to return my player's ball jersey in good condition upon completion of the season** or at such time that my player withdraws from ball. I agree that I will pay for this charge in accordance with the issuing bank cardholder agreement. This authorization will remain in effect until I return the jersey in good condition or this authorization is replaced with a \$100 signed, undated jersey deposit cheque or a \$100 cash deposit.

\_\_\_\_ **Volunteer Deposit** - I authorize the Elk Point Minor Ball Club to **charge \$300 to my credit card if I fail to present myself or a representative for any assigned volunteer shift; fail to complete the required volunteer duties for the season; or fail to complete the required fundraising for the season.** Volunteer (unpaid) shifts and duties may be assigned by EPMB or chosen by the member, such as concession booth shifts; diamond maintenance; coach/manager duties; scorekeeper/pitch count, and Canada Day dunk tank shifts. This authorization will remain in effect until the end of the ball season (August 31) or this authorization is replaced with a \$300 signed, undated volunteer cheque or a \$300 cash deposit. I may cancel this authorization in writing, and I acknowledge that doing so will suspend my player from participation in all Elk Point Minor Ball Club activities until such time as a new authorization or other volunteer deposit has been submitted to the association.

\_\_\_\_ **Fundraising Deposit** - I authorize the Elk Point Minor Ball Club to **charge \$300 to my credit card if I fail to complete the required fundraising duties for the season.** This authorization will remain in effect until the end of the ball season (August 31) or this authorization is replaced with a \$300 signed, undated fundraising cheque or a \$300 cash deposit. I may cancel this authorization in writing, and I acknowledge that doing so will suspend my player from participation in all Elk Point Minor Ball Club activities until such time as a new authorization or other fundraising deposit has been submitted to the association.
