2022 Canada Summer Games Official Application and Selection Process

Officials Criteria

1. Level 3 or 4 official
2. Submit a Criminal Background Check (Vulnerable Sector Screening)
3. Safe Sport Harassment Training will be mandatory. (provided by LC)
4. Must be 18 years or older as of January 1, 2022.
5. Applicant must be in good standing with their MA.
6. NOCP certified referee in the current year.
7. Copies of two recent evaluations completed. (*Provincial Championships preferred*)
8. Copy of 2022 evaluation upon completion (*no later than May 22, 2022*)
9. Must abide by all Canada Summer Games policies for participation.
(*See CSG policies below*)
 - Must be available for the duration of event including travel days without interruption.
Week one Female: August 5 – 14, 2022; Week Two Male: August 14 - 22, 2022
 - Understand and accept that CG officials **DO NOT** get paid.
 - Canada Games is a drug and alcohol-free event.

Officials may apply for both weeks of competition. Female and Indigenous officials are strongly encouraged to apply.

Interested, qualified officials should forward their application and resume to their Member Association and Lacrosse Canada for consideration by **November 30, 2021**.

Selection Process

1. Candidates submit Canada Summer Games Officials Application before deadline.
2. Applications are to be submitted to the Member Association and Lacrosse Canada.
 - Submit application to Member Association Executive Director
 - Submissions to Lacrosse Canada: James Buhlman, CG Technical Representative at james@lacrosse.ca
3. Member Associations will review and give recommendations on all applicants from their province to Lacrosse Canada. *Deadline: December 15, 2021*
4. Lacrosse Canada Chair of Officials, Lacrosse Canada Director of Domestic Development, Canada Games Referee in Chief, Canada Games Technical Representative will review all applicants along with MA recommendations and create a short list of applicants who move to the interview stage. *Deadline: January 15, 2022*
5. Officials' interviews will take place with the Lacrosse Canada Chair of Officials, Lacrosse Canada Director of Domestic Development, Canada Games Referee in Chief, Canada Games Technical Representative. *Interviews: February 2022*
6. References of candidates will be contacted. *Timeline: February / March 2022*
7. A team of officials with alternates will be selected and notified. *Timeline: April 2022*
8. Officials will be required to submit a 2022 officiating evaluation **no later than May 22, 2022**.
