22.1 PURPOSE:

- 22.1.1 The Halifax Hurricanes Ringette Association (HHRA) Equipment Rental Program has been made available thanks in large part to **Sport fund**.
- The program is designed to help reduce participation costs and encourage more families to participate in the exciting sport of ringette.
- 22.1.3 Funds raised through the Equipment Rental Program will be used to grow and maintain the program.
- 22.1.4 The program is available to new athletes at the FUN and U10 divisions.

22.2 POLICY:

- 22.2.1 The success of this program will be determined by the support and commitment of all who participate.
- Taking care of the equipment, while the participants are in possession of it and returning it in a good, clean condition will ensure the continued success of this program.
- 22.2.3 Equipment rental includes:
 - BNQ approved neck guard
 - Elbow pads
 - Shin pads
 - Shoulder pads
 - Hockey gloves
 - Ringette pants
 - Ringette girdle
 - Ringette stick
 - CSA ringette cage
 - Equipment bag

- 22.2.4 Equipment rental **DOES NOT** include:
 - CSA approved helmet
 - Skates
- 22.2.5 Participants of the HHRA Equipment Rental Program will follow the expectations listed below:
 - Athletes will wear a base layer under their equipment;
 - Equipment will be taken out of equipment bag and aired out after each use;
 - Athletes will ensure all pieces of their equipment have your rental number on it;
 - Ensure that your equipment is in your equipment bag at the end of each practice and game; and
 - Return all equipment in a good and clean condition.

22.3 FEES & DEPOSIT:

- 22.3.1 The Equipment Rental Fee is as listed in HHRA's 21.0 Rates and Fees Policy.
- 22.3.2 A Deposit made by postdated cheque, payable to the Halifax Hurricanes Ringette Association, dated April 15th of the following year, or credit card charge form, for the amount stated in HHRA's 21.0 Rates and Fees Policy is required.
- 22.3.3 Fees and Deposit are required before taking possession of the equipment.
- 22.3.4 The postdated cheque or credit card charge will be cashed/processed if:
 - The equipment is not returned at the end of the season; or
 - There is missing or damaged (*) equipment.
 - (*) Damaged = beyond normal wear and tear and the piece needs to be replaced. HHRA will deduct the cost of any damaged or missing equipment from the Deposit and refund the difference.
