Player & Parent(s) Commitment:

As a player within the Leduc Junior Athletic Club (LJAC) organization, I recognize that by signing this Player Code of Conduct/Agreement, I have committed to register with and remain a member of the team & LJAC for the 2021/22 hockey season.

- I agree to perform to the best of my ability, while following the direction of the LJAC coaches and program.
- I agree to be open to new challenges and come to all team events with the goal to get better each day.
- I accept that playing time is determined at the sole discretion of the coaches; and will be managed appropriately in accordance with the association’s developmental guidelines.
- I will make every effort to succeed athletically, scholastically and personally on and off the ice.
- I embrace the guiding principle of “Professionalism” in that I will treat all teammates, team staff, officials, opponents, peers and all others in which I come in contact with respect and dignity throughout the hockey season. Being a member of the LJAC/Team and Hockey Alberta/Alberta Elite Hockey League is an opportunity not a right.
- I will strive to be a good person and teammate and will not bully or intimidate any of my fellow players or opponents.
- I shall comply with all “Team Guidelines & Rules” as communicated by the coaching staff & LJAC and strive to be a good teammate and positive role model in the community.
- I embrace the spirit of competition in which athletes are expected to compete hard and fair and never compromise the safety of another individual. (Principles of fair play, sportsmanship and respect towards others)
- I understand that LJAC will not tolerate discrimination against any person (player, coaching staff, official, parent, board member, league representatives, etc.) because of race, color, national origin or ancestry, gender, age, religious convictions or disability.
- I acknowledge that a player may be released from the Player Agreement under the following conditions:
 - failure to attend school
 - use of tobacco products, illegal drugs & alcohol
 - use of e-cigarettes or vaping of any kind
 - consistently violating team curfews and rules
 - disrespectful behavior both on/off ice
 - failure to comply with other aspects of the team's “Guidelines & Rules”
 - Misuse of social media (*This includes the athletes & parents*) See Below:

LJAC endorses a high standard of behavior when using social media and does not condone any messages that:

- May constitute harassment, discrimination, racism, cyber bullying or violence;
- Are hurtful, malicious, degrading or otherwise offensive to an individual or group of individuals;
- Refer to controversial or potentially inflammatory subjects including, but not limited to, politics, sex, and religion;
- Are damaging to our brand and/or relationships with our stakeholders and funding partners;
- Divulge confidential or proprietary information that belongs to LJAC
- Fails to respect the privacy of others by disclosing personal information without consent.
- My family commits to pay the LJAC/Team registration fees as stipulated within the terms set out by LJAC.
- I understand that in the event the team registers the maximum number of allotted players, and a player who was released from a higher Division or Category, I may be released from the team to accommodate the returning player.
