2014 - 2015 Presidents' Report

In reflecting on the 2014 – 2015 season, it is clear that there are several different ways for measuring the performance of the organization, some of which will not be clear until the upcoming or even later seasons. Of course at the top of the list is the experience for the players. This year our players represented the associate well and enjoyed some success on the ice.

Travel Program

In the travel program 6 out of our 8 Lower Lakes teams qualified for the playoffs with three of our teams advancing to the second round. Four of our travel teams qualified for the OWHA Provincial Championships. Congratulations to the Bantam A, Bantam BB, Peewee B and Atom C teams! In addition our teams had strong showings at tournaments throughout the year with our Midget BB and Bantam BB taking gold at the Motown Cup tournaments, Peewee A team taking silvers in Markham and at our hometown Hocktoberfest tournament and the Peewee B taking silver in Kitchener.

House League

Our house league program consisted of 23 teams in Windsor, Tecumseh and Lasalle. Our teams represented our association well in the Essex-Kent league as well as several tournaments throughout the season. In our own Winter Wild tournament, SPFHA teams took gold in Atom, Peewee and Intermediate divisions congratulations to Atom Lasalle Blue, Peewee Tecumseh Orange and Intermediate Tecumseh Orange! Six of our teams will be playing in the EK Day of Champs.

Board Engagement

This was my third year as a member of the board and one of the most important achievements of this year's board was the engagement and contributions from each of our board members. In a year where there were many new faces and changes in roles on the board there were new initiatives brought forward and vigorous and passionate discussion about how to make a great experience for the players and families that make up SPFHA. - Skills Sessions I received very positive feedback for the skills sessions offered for both travel and house league players this year kudos to Mike Fockens for his hard work in developing the program this year and many thanks to his volunteers for coming out to help with these sessions.
- Sponsors Thanks to all of the companies and individuals that sponsored teams and individuals. This year we had three companies that sponsored divisions that I would like to acknowledge, Tim Horton's – Novice, McDonald's – Atom and WFCU who have partnered with us to sponsor our Peewee and Bantam divisons.
- Player Development A committee has been formed to focus on player development within the organization. It is hoped that this will bring together more resources within our association to enhance the experience and playing opportunities for all female hockey players. Report Out for SPFHA House League for 2014-2015 Season

The 2014-2015 season saw over 300 female hockey players participate over 23 teams and 3 locales in the house league program of the SPFHA. The numbers of teams and players were relatively flat season over season.

On the positive side of the ledger, most teams were very competitive and participated strongly in the EKGIHL, representing the association with pride and vigour. As well, at the Atom and above levels we had almost 100% of teams field a full time, dedicated goaltenders at the completion of the season, either through our players or by using the Female Development Player program of the OWHA. This success was aided immensely by the allocation of 5 sets of brand new goalie equipment from the Trillium Grant received by the EKGIHL. The quality of equipment is a big factor in the willingness of new goalies to try the position.

We had a very successful level of participation in the Windsor Wild tournament. In total, our teams won 4 tournaments and were finalists in many others. We had a very high rate of participation in the Weekly Skills Program at the Novice to Peewee levels. We had a very competitive Day of Champs within Sun Parlour with only one game having a margin of victory of more than 3 goals and 5 overtime and 2 shootout across 13 games. As well, 5 SPFHA teams will be participating in the EKGIHL Day of Champs at their Tier.

There were relative few discipline incidents this season as compared to past seasons. There were 2 player suspensions and 4 coach suspensions. There were 3 other incidents referred to the Executive VP/VP of House League for review/mediation. A prime concern this season is the number of incidents of reported head injury/concussion. This number will require ongoing diligence and policy development moving forward.

The association is fortunate to have so many skilled, dedicated and passionate coaches and volunteers to make so great the experience for all of our players. So many times this year, in the dozens of games I observed it would have been utterly impossible to divine the score of a game, even in lopsided contests by observing the interaction of the players on the benches or afterwards in a dressing room. Laughing, singing, cheering and supporting. It is almost universal to our teams and should be a source of immense pride to everyone involved in Female hockey at the House League level. This speaks so well of those coaches and trainers who make that happen through providing a great, safe and wonderful experience for the girls.

2014-15 AGM Ice Scheduler Report

I will say that my first season as ice scheduler has been a learning experience. This season we booked 1465 hours of ice at 6 different arenas, 4 arenas in Windsor and 1 in each of the towns of Tecumseh and LaSalle. 662 hours of ice was used for travel and the remainder for house league. Even with all the attempts made to maximize our ice usage we still burned 33.5 hours of ice this season representing 2.2% of our booked ice. The majority of this was ice that we booked for the travel play offs in February and March as well as ice booked in September. This is virtually unavoidable as some of this ice gets cancelled at the last minute when play off series end early.

Even with all of this I did manage to return about 25 hours of ice to the city or we would have burned even more ice. The city is tightening up on returning ice next season and won't allow us to return any ice from our contract except in March.

Next season will pose some interesting problems as well. With Easter falling in the last weekend of March, a decision will have to be made on when to end the season. This will be up to the next board. Also the city will be increasing the cost of ice next season, this will obviously have an impact on the association.

I would like to thank Roy Henry and Gary McIntyre as we worked together to insure that there were referees for all scheduled games. I also want to thank all the travel coaches and managers who were very cooperative and understanding when we were trying to book their regular season games, play off and play down games. At times it was a bit difficult but I think we managed to get all the games scheduled at times that worked for all involved.

I look forward to another season in my position and hopefully we can find a way to decrease the amount of burned ice to almost none.
