#### **New Business**

- ➤ Discussion regarding length of season, SPFHA Day of Champions and March Break Can Day of Champions can be moved up so that there is not a gap in play over March Break. It is very difficult to do so as the City of Windsor dictates the last available ice time and there are some tournaments the week before March break that our house league teams participate in. Any coach could to pick up more ice time for exhibition games or practices if desired by contacting Ice Scheduler.
- ➤ During holidays where attendance for games and practices is lower and for times when DS teams have tournaments, 3 on 3 exhibition games can be organized so that the remaining players can benefit from additional skating time.
- ➤ Rob Modestino attempted to schedule all DS ice time around all house league games and practices.

- ➤ Can the Board of Directors accept help from them the members at large? Members can participate in committees that report to the Board of Directors. If interested in volunteering please let a Board Member know.
- ➤ Will the Board contemplate increasing the travel team roster in the higher levels. These teams often play short as injuries arise throughout the season. Board of Directors will discuss at next board meeting. Keep in mind SPFHA must follow the OWHA guidelines for player roster.
- ➤ Board will discuss expanding Baseline Concussion testing to house league. It was well received within the travel program. Costs and response from those that had participated will be taken into consideration.
- ➤ Applications for coaches for the house league and DS programs will be posted upon completion of the travel try outs.
- ➤ Discussion ensued regarding \$300 registration fee for new players entering the SPFHA system. This decision was passed by the Board of Directors in an attempt to increase our numbers within all divisions. The Novice Division will definitely benefit from this initiative as the number of registrants has already increased for next season.
- A Novice DS team did not run this year as there were not enough players to support the program. The goal is to reinstitute the Novice DS team next season. SPFHA would like to see a DS team in all divisions.
