SPFHA continues to develop and evolve with our main goal to encourage young females to be physically active and participate in a sport they love!! We continue to work to create successful programs that provide fun, skills development and encourage a love of hockey for members of the Association.

Without the tireless work of the volunteers within our Association, be they coaches, board members or parents, we would not be enjoying our current successes nor would we be able to develop go forward plans for our future.

This year's Board of Directors has dedicated countless hours to insuring that our Association is successful both on and off the ice.

This year, we participated in several local events to get the word out about Sun Parlour. Report of the Vice President of House League of SPFHA 2017 Annual General Meeting:

People believe that travel hockey is the most important aspect of any hockey association, however, the house league component represents over 75% of all revenue to associations.

That being said it is crucial we continue to assess and develop opportunities to maintain and increase our house league registration numbers. Based upon talking to people in the community, there still is a lack of knowledge that female hockey is alive and well in our region. It has been ten years since the opening and expanding of female hockey into Lasalle and shortly after the expansion into Tecumseh. Although we have had good success, we believe there is a need to increase the awareness of female hockey through various means to solidify SPFHA hockey into the future.

Since our association encompasses three regions it is crucial we have solid Standard Operation Procedures in place and available to members. Next fall we have available to all members the SPFHA House League Manual. This manual is a quick but thorough document that outlines all aspects of house league hockey with SPFHA for coaches and parents.

Although novice registration numbers are down this year, we believe we still have a solid base in place with various programs to increase our numbers to more historical averages. SPFHA has taken the lead in requesting the expansion of the Essex Kent Girls Interlock Hockey League (EKGHL) to include a novice division starting next fall. All associations have approved in principal the plan to expand to include novice teams and all have agreed there needs to be a proper plan in place for the players to develop their skills through the models of Hockey Canada. Playing games alone will not improve your child's hockey skills, but a proper development plan along with games will increase their hockey knowledge and skills.

This year our house league component had one novice, three atom, two peewee, five bantam and nine midget/intermediate teams which is down one peewee and one midget from two years ago. Lasalle is the only region where we have had an increase in our enrolment. The goal next year through various means will be to increase each division by one team. Registration rebates along with First Skate should help increase our house league numbers.

Next year we plan on increasing our media presence in the community by adding SPFHA banners to all three centres. There has also been discussions to centralize our Windsor team games including travel teams to one arena.

The DS program was reintroduced this year for the atom and bantam division. Both teams had a successful season in tournament play. Notably, the bantam team remains undefeated and hope to sweep tournament play this weekend in Brampton. The goal for next year is to expand the DS program to include teams in all divisions. Coaching Applications will be available on the website sometime this summer.

Although player suspensions and discipline in house league declined this year, head coach and coaching staff discipline and suspensions increased for our association. SPFHA will continue to investigate all matters to the fullest and make necessary recommendations that are brought forward by the committee. Coaching is not a right but a privilege. As indicated in our House League manual, the head

coach will be selected based primarily on their coaching and playing experiences, and other credentials. Past history and the ability to follow operational instructions from the SPFHA Board of Directors will also be considered. More specifically, being able to work with other coaches and alongside the house league director and the VP of house league is critical! Examples where coaches can be overlooked include any suspension a coach receives. Failure to follow basic rules including fair play, knowingly use illegal players, sending out mass emails when dealing in sensitive matters, and failing to follow the proper chain of command.

Report of the Registrar of SPFHA 2017 Annual General Meeting

The 2016--2017 season was once again a successful year for SPFHA.

Registration topped out at 421 players registered in SPFHA.

There were 27 less girls this season than last season, with our biggest drop being in the Atom division - with no travel teams in this division. This situation will hopefully be remedied with the addition this year of travel teams at the Atom level.

The other divisions stayed around the same numbers as last season.

This coming season's registration started (in person) on Day of Champs which was at South Windsor Arena on Sat. March 25, 2017

Online registration opened on April 1, 2017 through our website at www.spfhahockey.com.

Below are registration fees for 2017--2018 season.

Novice-- \$550

Atom--Intermediate----- \$600 (Before August 1, 2017) (after August 1, 2017 there will be a nonrefundable \$50 late fee added to the registration fee)

This season we instituted a first OWHA registrant fee of \$300 - this along with the successful First Start Program has seen an increase in Novice registrants as well as new players in other divisions.

We will continue to give \$100 rebate to any house league goalie that plays in net for the entire season.

They will be reimbursed at the end of that season.

We will also continue to give the \$50 multiplayer discount.

Report of the Ice Scheduler of SPFHA 2017 Annual General Meeting

This season we booked 1201 hours (down 108 hours from last season) of ice at 6 different arenas, 4 arenas in Windsor and 1 in each of the towns of Tecumseh and LaSalle. 563 hours of ice was used for travel (including DS teams), 38 hours for skills development and the remainder for house league. Even with all the attempts made to maximize our ice usage we still burned 45 hours of ice this season representing 3.7% (down 1%) of our booked ice. The ideal goal would be to get this below 3%.

Although our ice cost was down this season, ideally we would like to see all house league teams with at least 14 players which would maximize our return.

The 100+ hours of savings was mostly accomplished by returning 2 hours of ice on Sunday afternoon and 1 hour of Friday night ice at Tecumseh. I did manage to eliminate one of our 5pm practice times and improve the late Tuesday night time for the midgets.

I would like to thank Roy Henry as we worked together all season and especially through the playoffs to insure that there were referees for all scheduled games. I also want to thank all the travel coaches and managers who were very cooperative and understanding when we were trying to book their regular season games, play off and play down games. At times it was a bit difficult but I think we managed to get all the games scheduled at times that worked for all involved.

Moving forward whether it's me or someone else in this position, the goal is to try to bring our burned ice below 3% and to try to continue to improve some of our ice times. This would mean decreasing the burnt ice by as little as 8 hours.

This happened through the induction of special “3-person” system games in our Midget house league system, as well as at the Bantam and Midget travel. Each linesperson was put with an experienced line partner and a senior head referee. It was great to see so many officials experience this “next level” and we hope to continue developing future linespeople next season. The referee association is thankful to the Midget house league system that allows us to train our referees during inter-squad games.

The referee association is happy to see a solid crew of officials heading up to the 2016-2017 Provincials the weekend of April 6-9. I am confident they will make our local association proud as they officiate the top teams in Ontario this past season.

This season will see the first inaugural end of season Referee Association event to celebrate all of the hard work our officials put in throughout the season. Along with this event, there will be four separate awards given out. The awards are as follows: Timekeeper of the Year, Most Improved, Best Partner on the Ice, and Referee of the Year. The refereeing association showed great pride in their fellow referee partners by sending in the names of many hard-working candidates.

In sum, as a referee association we will continue to work towards developing our officials to our best ability in a positive learning environment. We appreciate the support and positive attitudes from many coaches, players, and affiliates of Sun Parlour Female Hockey Association. We look forward to the 2017-2018 season.

The email database continues to be a challenge and requires constant updates due to the nature of members changing email addresses. Past teams and seasons have also been culled from the email database to streamline it.

It has been my pleasure to serve as a board member and webmaster for the past year and look forward to next season. I would like to thank the association and its membership for their support.

Report of the Equipment Coordinator of SPFHA 2017 Annual General Meeting:

Before the start of our 2016/2017 season we moved our equipment room from South Windsor arena to Forest Glade arena. This allowed u to have a more equipment friendly environment; better lighting, more room, and dryer storage.

This year we lent out 10 sets of goalie equipment to our house league goalies. Each set consisted of mainly new equipment received through the Trillium program. This season we received our last sets of goalie equipment from the Trillium program.

This year's photo day was a big success. We went with a different photographer than the previous season, Brooks Photography. The photo day ran quite smoothly and we were able to stay on schedule. The quality of the photos was excellent, and the delivery of them was quick.

As this is my first season with equipment, I wanted to see as many of the house league teams as possible to see how their jerseys and socks looked on the ice. I looked for clarity of all the logos, how the colour looked, how visible the numbers were, how well the jerseys fit, and if the socks matched. The first thing I noticed, the socks. For the upcoming season the socks will not be plain there will be a stripe on them. Second thing I noticed was a couple of the colours selected did not look as good as we had hoped or they were too close in colour to another jersey colour. I asked for some yearend feedback from the coaches, a few replied. Some suggestions were: all goalie cut jerseys for goalie, l0ok at some different jersey colours, better quality jerseys.

This season we were able to have one of our suppliers open an online store for apparel. We had online shopping or each section of SPFHA with the exception of the Southwest Wildcats. The girls from Tecumseh Tigercats, LaSalle Sabrecats, and Windsor Wildcats, were able to order directly from the supplier.

For our travel program, we went with a different supplier this season. They coordinated a fitting day for jerseys, uniforms, and apparel. With the travel girls, I was able to see how their home jersey fit, how the colours looked, clarity of the logos, numbers, names, and sponsor bars. I was able to speak with a few of the coaches about their girls on-ice and off-ice uniforms, all had positive responses.

Proposed Constitutional Amendment #1

**As proposed by Craig Hilton via email February 18, 2017

To amend the following:

1.0 NAME OF ASSOCIATION

1.1 The name of this organization shall be THE "SUN PARLOUR FEMALE HOCKEY ASSOCIATION", hereinafter referred to as "the Association" or "SPFHA". The official logo of the association shall be



1.2 Competitive Teams: the official team name for all competitive teams is "Windsor Wildcats". (with the exception of the PWHL team)

1.3 House League Teams: the official team names for the community-based house league teams are:

- i. Windsor Wildcats
- ii. LaSalle Sabrecats
- iii. Tecumseh Tiger Cats

Proposed Constitutional Amendment #2

As proposed by Mike Martin and Jeff Hoskins via email on February 20, 2017

To amend the following:

4. The Conveners of the Association shall consist of the following:

Director of House League Operations.

- With the exception of the Immediate Past President and Development Committee Chair, the Executive Officers shall be elected for a two-year term at the Annual General Meeting.
 - i. **Remove and Development Committee Chair**
- Amendment to Section 5.1 (6)
- The Development Committee Chair shall be confirmed by the Board following consultation with the Development Committee. This appointment shall be for a minimum of one year and shall renew annually until such time as the Development Committee Chair resigns or is removed by a vote of the Board.
