- Skate guards with wheels are banned from all city arenas as is playing stick hockey off ice.
- Dressing rooms 30 minutes before and 30 minutes after.
- Last year issue where fire alarm sound and coaches refused to clear out and leave the arena. All teams must follow the instructions announced overhead.

Dawn – OWHA meeting spoke of Rowan's Law, regarding concussions. Looking like it will be passed in Canada.
