Item Discussed: Arbiter

- Jack McLaren requested a meeting with the board to present new idea the SPFHA Arbiter.
- We were unable to coordinate a meeting at that time.
- Jack decided to resign as Referee in Chief for the SPFHA due to his new association with this new idea.
- As a result Jack was removed as administrator of the SPFHA.
- After much discussion with Jack and Roy Henry, it was decided that Jack would attend this month's meeting to present the Windsor Girls Ref Association's plans for a newly formed arbiter.
- Jack, Debbie Hands, Roy Henry and Jody Meyers joined the meeting for presentation.
- They would like to charge each association a predetermined fee for the use of their arbiter based on the number of games played. The administration fee would also be included in this charge.
