- Looking for one extra hour of ice on Sunday after the Novice/Initiation program ice time.

- She is proposing a coaching development and payer development program using the U of Windsor coaches and players by:

- Working together How can the Lancer service us?
- Discussion amongst board currently we use the Southwest Wildcats to work with player development. SFHA will have to look at how this will affect our program.

Item Discussed: First Shift – Mike F.

- 25 players in current First Shift.
