- Prior budget reports: working on 2017/2018. Requesting registration history regarding amounts collected for registration each year. Jim can get this information as far back as 2016/2017.

Item Discussed: Non-registered (non-insured) players – Rob

- A travel team used an AP player from another association.
- Cannot have players from other associations play for any SPFHA travel team.
- All players must be registered/rostered prior to playing.
- Equivalent level or lower level players can AP.
- Discussion regarding process for approval of AP players.

Item Discussed: Monetary donation from Emery Financial for exhibition game jerseys - Steve

- Emery Financial pledged \$1000 towards the purchase of 2 new sets of tournament and exhibition jerseys for Novice. Steve is requesting \$301.76 from SPFHA to cover the remaining cost for the jerseys.
- Motion to cover the remaining cost of jerseys by Steve, 2nd by Jen. Carried unanimously.

Item Discussed: Girls Hockey Weekend - Steve

- Weekend of October 4th.
- Steve is willing to take the lead.
- Sam has already registered for event.

Item Discussed: Discontinue Initiation in 2020 - Steve

- Recommends that SPFHA consider not running Initiation program next year.
- There is a large age gap between Initiation and Novice players.
- Ages 4-8 on ice at the same time
- Discussion regarding initiation.
- Will recruit more volunteers to work with younger girls.

Item Discussed: Midget 2 team roster addition – Dawn

- Attempted to have one midget/intermediate house league team with only midget aged players in order to provide AP players for the Midget 2 travel team.
- Midget 2 roster has been approved to carry 16 skaters.

Item Discussed: ESSO Fun Days for women new to hockey

- Looking to host a free event for women new to hockey.
- Will look at creating an event later in the season.

Item Discussed: House League update - Dana

- Should consider looking at house league as SPFHA and not centers.
- Many registration requests for the same center. Once team fills up must move players to a different center.
- Recommends accepting only a main coach and trainer.
- Need to create rules for rostering players.
- Discussion as to having to keep LaSalle in order to receive ice time at the Volmer.
