 - We have not yet been able to secure sponsorship for the Social Media Series, but if we can continue to drive traffic to the pages, our viewer/follower counts go up and will start to provide value to sponsors.
 - Work continues on the LGB Border identification; any changes agreed to at this point will then be brought to the Board of Directors to ratify

- RMLL was split on 22 year old players playing junior

- Lisa is the ED on the Member Council and MA ED's are meeting monthly
- CLA formed a committee to look at financial aid for MA's
- CLA Business plan will be staggered with rebranding and new web site
