1.0 OVERVIEW

All players must be registered with AMHA before participating in any on-ice activity. They must reside in the AMHA boundary unless exceptional circumstances, see below in 4.0 of this policy.

2.0 FEE POLICY

2.1 Fees

Each year the Executive Committee will do an analysis of our costs for each separate level and division to determine the registration fees for the upcoming season. These will then be posted on the website for our membership.

These will be the costs that members will have to pay to play hockey in the upcoming hockey season. This fee cost analysis will also include items like Acceleration fee, Pre-season and Spring Camp fees, etc.

In the event that a family is in need, they will be able to register without paying the full fee and can make use of organizations like KidSport and/or Jumpstart after letting the office know.

2.2 Late Fees

Based on cut off dates to help with planning the Executive Committee will determine a Late Fee for existing members registering after a certain date. If you are new to Airdrie, then you will not pay a late fee. The late fee is \$250 after the date set and posted by the Executive Committee annually as per policy #7.1 (3.1.3) and is non-refundable and based on numbers, you may be put on a waitlist.

2.3 Payment Options

At the time of registration, a member can pay in full or elect to just pay a non-refundable deposit of \$75, plus any high performance tryout fees or conditioning camp fees, to hold their spot and then pay 3 equal payments of the balance of the base fee for their child's division on August 1st, September 1st and October 1st. If the player is trying out for AA or

a Travel team and makes the higher team, then on November 1st, they will be charged the difference between the higher rate and the base rate.

2.4 Unpaid or Overdue Balances

If all applicable fees for a player are not paid in full or arrangements made, with the AMHA staff by November 30th, the player will no longer be allowed on the ice until payment in full is made or a scheduled payment arrangement has been set up.

- 2.4.1 If a scheduled payment arrangement becomes unpaid or overdue then the player will not be allowed on the ice until further arrangements are made.

3.0 DATE POLICY

- 3.1 Each year the Executive Committee will decide on the dates to open and close registration for existing members.

- 3.1.1 Opening date of registration
- 3.1.2 Last day for regular registration fee
- 3.1.3 Date that late registration fee starts
- 3.1.4 Last day for existing members to register

4.0 EXCEPTIONS TO BOUNDARY

All players must reside in the AMHA boundary, no players from outside the boundary will be allowed to play in AMHA with the exception of the following:

- 4.1 Players whose local MHA does not have a division for them to play and thereby required by Hockey Alberta guidelines to register with AMHA.
- 4.2 Female players whereas the Home Association does not have a female team or division.
- 4.3 If AMHA is requested by another MHA to include players in our system. This will only be allowed where all Hockey Alberta qualifications are met and agreed to by the Executive. This will only apply for the season the request is made.
- 4.4 Annually the Executive Committee will decide if we are allowing imports or players who fall within our draw zone to try out for our U13(PeeWee) AA, U15 (Bantam) AA, U15 (Bantam) AAA, U16(M15) AA, U18 (Midget) AA and U18 (Midget) AAA as a second tryout.

All new to AMHA registered players must show proof of residency by way of a city utility bill, driver's license and/or lease/purchase agreement.
