



MOTION – To elect Two (2) Director-At-Large to a One (1) Year Term

REASON: Two current Directors-At-Large are resigning midterm. These open positions will be subject to a 1 year term to maintain balance for future APRA Board elections (i.e. 6/12 elected per year).

In 2024, APRA will return to 6 open positions to be elected to 2 year terms.
