#### 6.4 Multiplex Facility Concerns

- Heating and lighting concerns have been expressed to ADMHA executive members by hockey families and spectators.
- The arena temperature is too cold, uncomfortable for most people, heater in time box has been removed by Multiplex staff as it is melting the ice.
- Lighting issues such as lights being turned off between periods and this is a safety hazard for all in attendance. During a Pee Wee game the referee would not start the game until ALL lights in the arena were turned on.
- Safety hazards- ice surface is too wet (too much water from Zamboni), ice corners are too deep, ice is too soft. Complaints received from players, coaches and referees.
- Action Item: ADMHA will write a letter to ARMS Board to express above noted concerns. It will also be noted in the letter that there is a lack of communication by Multiplex to ADMHA. Vice President Miller will sign the letter on behalf of ADMHA executive.
