5. Business Arising from the Minutes

- 5.1. Pigs 'n' Pianos event
 - 5.1.1. Greg Kociuba and Trisha MacGregor updated exec on event planning to date. Rescheduling the event has to coordinate multiplex, caterer, and entertainment. Athabasca Rotary is planning an event in Oct. The pianos entertainment is booked solid for Oct and Nov. Sep long weekend is the only one available in Sep at the Multiplex. Friday of the long weekend is best date to allow people to have rest of long weekend. The organizing committee has tentatively booked Sep 4 at multiplex. The piano entertainment is holding Sep 4 and Sep 11 for us. Multiplex is not available Sep 11 to best of their knowledge.

- 6.1. No body checking at Bantam/U15 Tier 4, 5, 6 Dustin Pysyk
 - 6.1.1. Proposed pilot program from Hockey Alberta. Tier 1, 2, 3 would have body checking. Tier 4, 5, 6 would not.
 - 6.1.2. Most board members were against the proposal: it could cause tier 2/3 players to drop down to lower tiers and be impact players, players may move between checking and non-checking tiers through affiliations or from season to season and will be much less prepared for checking, may result in players deciding not to play
 - 6.1.3. Some board members were for the proposal: it would give players an option to continue playing hockey with no body checking
 - 6.1.4. Experience with Bantam 2 team this season was that there wasn't a lot of big body checks.
 - 6.1.5. Dustin will complete the Hockey Alberta survey on this topic on behalf of ADMHA based on the majority of the executive members voicing opposition to the proposal.
- 6.2. Hockey Pools Kelly Rich
 - 6.2.1. Kelly will contact AGLC for guidance on how to proceed with the Hockey Pools given the suspension of play in the NHL.
