1. Call to Order

1.1. Meeting called to order at 6:37 pm by Dustin Pysyk

2. Approval of Agenda

2.1. **Motion:** To approve the agenda as amended. Moved by Rhonda Alix. **Motion** carried.

3. Approval of Previous Minutes

3.1. **Motion:** To approve the minutes of the September 23, 2020 meeting as presented. Moved by Jen Miller. **Motion carried.**

4. Ratification of email votes

4.1. **Motion**: To accept registration of 3 skaters and 1 goalie from Boyle and 4 skaters from ADMHA at U18 in order to form two U18 teams. Motion by Jen Miller. **Motion carried.**

5. Business Arising from the Minutes

- 5.1. Coaching applications update
 - 5.1.1. Have a head coach at U7, but need an assistant in case he is away.
 - 5.1.2. U9 no change
 - 5.1.3. U11 1 head coach, and have an assistant that would reluctantly move to head but is away for work frequently. Have a number of assistants.
 - 5.1.4. U13 no change 2 head coaches, 1 assistant
 - 5.1.5. U15 2 head, 1 or 2 assistants
 - 5.1.6. U18 1 head coach and 1 assistant so far. Have another that would be willing to step up.
 - 5.1.7. Brett has reached out through division coordinators calling for more coaches.

5.2. COVID-19 protocols update

- 5.2.1. Jen Miller has built a checklist for all groups for contact tracing and dressing room. Some minor changes will be required. We will handle this outside of the meeting.
- 5.2.2. Information will stay at Multiplex so that it is accessible if required by AHS
- 5.2.3. When teams are made, new lists will be created
- 5.2.4. Each team will have a cohort liaison responsible for ensuring the team is following protocols and tracking attendance
- 5.2.5. Dustin will confirm with the multiplex that we are able to use the bench in the hallway for tying skates at U7 and U9.

6. New Business

- 6.1. Late registrations at U11, U13, U15 and U18
 - 6.1.1. **Motion:** To accept late registrations for 1 U11 player, 2 U13 players, 2 U15 players, and 4 U18 players. Motion by Rhonda Alix. **Motion carried.**
 - 6.1.2. U7 have 6; have room for 30+
 - 6.1.3. U9 have 12; have room for 3
 - 6.1.4. U11 have 29; have room for 1
 - 6.1.5. U13 have 31; full
 - 6.1.6. U15 have 28; have room for 1
 - 6.1.7. U18 have 31; full
 - 6.1.8. **Motion:** To pre-approve additional late registrations up to 30 at U7, 3 at U9, 1 at U11, and 1 at U15. Motion by Jen Miller. **Motion carried.**

6.2. Waiving late registration fees

6.3. Evaluation process for 2020/2021 season

- 6.3.1. Hockey Canada development model says that U11 cannot use previous years information for evaluations. They must have 4 skates, at least one with full ice.
- 6.3.2. We have 7 kids at U18 and 3 at U15 that were not with ADMHA last year.
- 6.3.3. Jen Miller contacted Bar Down about running evaluations and received a quote.
- 6.3.4. **Motion:** To hire Bar Down Education and a to be determined goaltending evaluation company to conduct evaluations for the 2020/2021 season. Motion by Jen Miller. **Motion carried**.
- 6.3.5. Jen will contact Bar Down and goaltending company for schedule details and work with the multiplex
- 6.3.6. **Motion:** To approach our player development contractor from last season to sit on the Evaluation Committee. Motion by Jen Miller. **Motion carried.**

6.4. Multiplex COVID-19 protocol update and concerns

- 6.4.1. Dustin sent email to the membership about concerns from the multiplex with our members not following their protocols.
- 6.4.2. Multiplex could have clearer protocols and better signage.
- 6.4.3. Dustin will talk with the multiplex to clarify their protocols.

6.5. Cohort groups and mini pod play

- 6.5.1. Hockey Alberta and NAI are recommending that team sizes be no more than 15 players and 2 coaches in order for cohort groups in mini pod play to be no more than 50 people total.
