# 4. Ratification of email votes

4.1. **Motion:** That ADMHA increase the pay rate for the player/coach mentor contract to \$65 per session. Motion by Brad Sakowich. **Motion carried.** 

### 5. Business Arising from the Minutes

- 5.1. Finalize tiering Dustin Pysyk
  - 5.1.1. Both U18 teams are good where they are tier 1 and tier 5
  - 5.1.2. U15-1: suggest getting an exhibition game against Slave Lake to help determine tiering as schedule has been only against tier 3 teams
  - 5.1.3. U15-2: games have been reasonably competitive so far.
  - 5.1.4. U13-1: have lost all games so far, but not by large margins.
  - 5.1.5. U113-2: have been playing tier 4 and higher so far and have lost by large margins. Dustin has been in contact with the league, and games have been adjusted to more appropriate opponents
  - 5.1.6. U11-1: in tier 2 right now, but Dustin has requested that they play tier 3 teams.
  - 5.1.7. U11-2: ok in tier 5
  - 5.1.8. Dustin will provide an update after this weekend's games if needed.

### 6. New Business

- 6.1. League update Dustin Pysyk
  - 6.1.1. No online game sheets this year.
  - 6.1.2. HCRs have to be updated so that they match the game sheets. This will be communicated at coaches meeting on Oct 20
  - 6.1.3. Affiliation process the league has a chart/process that we must follow.

- 6.2. Provincial bid Dustin Pysyk
  - 6.2.1. U18-1 has put in a request that ADMHA put in a bid to host provincials.
  - 6.2.2. It would be good to have the whole association be involved to assist.
  - 6.2.3. **Motion:** That ADMHA support a bid to host U18 tier 1 provincial tournament. Motion by Jen Miller. **Motion carried (Brad Sakowich abstained).**
  - 6.2.4. **Motion:** That association volunteer hours be used in hosting the provincial tournament if the bid is successful. Motion by Jessica Wysosky. **Motion carried.**
  - 6.2.5. Profits from the tournament will be used for player development.

  - 6.3.1. Had an idea that an electronic kiosk could be used to promote our players who have moved to higher levels, game schedule, etc.
  - 6.3.2. Royal Lepage is willing to rent time to ADMHA on their kiosk at \$400/month for 30 minutes airtime per hour. Rotation would be 5 min hockey, 5 min Royal Lepage
  - 6.3.3. Could potentially look at just purchasing a TV and have an agreement with the multiplex for it.

  - 6.4.1. Motion: To go in camera at 7:32 pm. Motion by Jen Miller. Motion carried.
  - 6.4.2. Motion: To come out of in camera at 7:37 pm. Motion by Jen Miller. Motion carried.
- 6.5. 50/50 opportunity for Multiplex concert Oct 30 Jessica Wysosky
  - 6.5.1. Delerium is doing a concert on Oct 30 and approached Jessica to have ADMHA run a 50/50. They are asking for a certain number of people, so that seems like they are really wanting security.
  - 6.5.2. Jessica recommends that we pass on this opportunity because we don't do security. The rest of the executive agreed to pass.
