## 5. Business Arising from the Minutes

- 5.1. Evaluation policy Scott Gray
  - 5.1.1. Scott presented the draft evaluation policy. Aim is to clarify the procedures around evaluations, especially around players returning from AAA/AA tryouts, absence due to injury or illness, underage players, players wanting to play both as skaters and goaltenders, goaltenders.
  - 5.1.2. Deadline for finalizing this policy will be in July.
- 5.2. Survey Scott Gray
  - 5.2.1. General feedback from the board looking at the survey was positive.
  - 5.2.2. Scott will try to get the survey out soon, and it will close in mid-April.

#### 6. New Business

- 6.1. Financial report Keagan Maki
  - 6.1.1. Will need to complete an AGLC reconciliation report before May 1, 2023.
  - 6.1.2. Ice fees for this year are projected to be around \$110,000
  - 6.1.3. Current financial report shows a net loss as of today of \$56,000.
- 6.2. 2023/2024 fees Scott Gray
  - 6.2.1. We all know that we have very low registrations at the youngest age groups. We should consider reducing the fees at those age groups provide an incentive to registration.

- 6.2.2. Scott spoke with Ron Bay (RIC), and he believes that our officiating costs will increase substantially next year. Mainly due to limited availability of senior referees.
- 6.2.3. How do we use our savings? To be discussed at the AGM.
- 6.2.4. **Motion:** That the fees for the 2023/2024 season be the same as the 2022/2023 season, except U7 be \$200 and U9 be \$450, and the AGM and new to hockey incentives remain in place. Motion by Scott Gray. **Motion carried.**
