- 4. President's Report (Matt Purdy)
- 2024 season successful with teams at U3 through U13. There was a Girls U15 Team. No boys U15 team and no U17 teams.
- The Girls U15 team played in provincials and represented Athabasca well.
- AGLC changed casinos are awarded and to maintain our upcoming date in Feb we need parents and family to take part, or we lose our casino. We need to have 6-7 representatives to be connected to ASA.
- Had enough coaches but always looking for more help.
- Thanks to the Board for their hard work.
- 5. Financial report (Jody Fedun)
  - a. As of Dec 31, 2024 there is \$56, 799. 61 in the General Account
  - b. As of Dec 31, 2024 there is \$ 33,445.50 in the Casino Account
  - c. As of February 6, 2025 the balance is 79,701.94
  - d. As of tonight the Casio only has one parent volunteer and we are in jeopardy of losing our casino. Chery Gorski and Neil Kuly did come forward as options. Kate will put out ads on Facebook and the website to help get the word out.
- 6. Coaching director report (Laura Hynes)
  - a. Thanks to coaches
  - b. All teams filled last year (one age group was delayed until coaches came forward)
  - c. Grassroots training may come to Athabasca watch for announcements.
  - d. Soccer for Life and other training will be paid. Coaches for U11 and up need certifications.
  - e. Criminal record checks are good for three years and can be loaded into RAMP.
- 7. Registrar report (Mat Rosychuk)
  - a. Last year in outdoor we had 136 registrations, down a bit from 2023.

- b. In the previous year (2023) we ran a split indoor season with 59 + 32. This year the season ran over both and had 42 (2024). This was well received but there were some booking issues over Christmas and will recommend that we close down soccer over the break.
- c. RAMP works well for registration but has challenges with the mass email system.
- d. For the coming year the U11 and above will need player photos loaded at time of registration.
- e. Outdoor season aims to start April 7th tentatively with registration open March 3rd.
- f. ASA is coordination with minor ball so that kids under U11 don't have to chose if families want to participate in both sports. U11 and up are scheduled via Tri-County and cannot change.
