



INTRODUCTION:

The Aurora Soccer Club Inc., which is the registered owner of the business name Aurora Soccer Club, (hereinafter referred to as “the Club” or “the Zone”) was established in 1996 as a non-profit corporation under *The Non-profit Corporations Act, 1995* of Saskatchewan. The Club is affiliated with, and governed by, Saskatoon Youth Soccer Inc. (hereinafter referred to as “SYSI”). The Club is recognized as the governing body for youth soccer in Saskatoon Zone 3. The Saskatchewan Soccer Association Inc. (hereinafter referred to as “SSA”) governs the sport of soccer for players, coaches, referees, and administrators in the province of Saskatchewan.

Aurora Soccer Club operates within Treaty 6 territory and that we play soccer on the traditional and ancestral lands of the Cree, Dene, Blackfoot, Nakota and Saulteaux First Nations and the homeland of the Metis Nation. We are dedicated to ensuring that the spirit of Reconciliation and Treaty 6 is honored and respected.

The Club membership is limited (subject to certain exceptions set out herein) to the area designated by SYSI as Zone 3, which currently includes the geographic area within the City of Saskatoon which includes the following communities Arbor Creek, Aspen Ridge, Evergreen, Erindale, University Heights, Willowgrove and Brighton. The geographical area outside of Saskatoon South Saskatchewan River North of the city and Highway 5 and extending due East.

The zone of residency of players shall be the residence of the legal guardian of the player as of the common registration date set seasonally by SYSI.

The objectives of the Club are:

- To promote and assist the development and enjoyment of soccer for all players in Zone 3 or such similar or replacement zone which may be established by SYSI,
- To promote interest, participation, and excellence in the sport of soccer in Zone 3 and to promote soccer wherever and whenever possible,
- To develop and foster the concepts of fair play, teamwork, competitive sportsmanship, ethical behavior, and good fellowship amongst all those involved in soccer, and through the actions of all members and players, demonstrate our beliefs in these ideals to all others involved in soccer,
- To abide by the rules and regulations of the sport of soccer in the spirit of competitive fair play,
- To use the resources of the Club to:
 - build team structures which will provide continuity and consistency in both playing opportunities and in coaching and provide opportunities to play on teams and in divisions compatible with skill level.



- o recruit coaches and encourage continual improvement in coaching through clinics,
- o courses and the exchange of ideas, skills, and expertise among club teams.
- o provide opportunities for Club teams to experience appropriate levels of competition to further their development.
- o assist the community associations within Zone 3 in the development of programs to encourage participation in and the development of player and coaching skills at the mini soccer level.
- o meet and collaborate with other soccer entities at any organizational and technical level.
- o Advocate and lobby for changes and improvements at all levels of administration where necessary or desirable to further the objectives of the Club.
