VIII. Equipment Update – Meghan & Bryce

- **a.** Asset Panda could be good if we had a way to track the quality of the equipment or if the equipment is in or out Asset Panda is out and will not be renewed going forward
- **b.** Bryce is building an equipment tracker on excel and would like to go through the gear to rank it on wear etc; we need to go through jerseys
- **c.** We will need buckets his wife works at Home Depot with letter we could probably get these donated
- **d.** First Aid kits restock and need some more; we need a list as to what should be in them; can we offer this out as a bond to have someone restock the kits with the supplies we give them. What's more cost effective? Buying new or restocking.

- g. We need a committee of 4 or 5 people along with control people for at least two days (equipment one day, jerseys another day)
- h. First priority is to know what we need for goalie equipment and jerseys Chris does not think we should have to order equipment, but we should really have goalie jersey's – Chris will call about the jerseys
- i. Second priority is cleaning of the equipment Chris will call Max Bell
- **j.** Is there some way we could offer a voucher to the goalie families so they take their equipment in to be cleaned opposed to bringing it in and handing it back out.
