- a) ALA Update in accordance to the Bylaws Deb Rhodes will assume the president role until the next AGM in Nov

- d) Evaluations Divisions the most efficient and timely way to do evals is on paper using the data from last year and the year before to make up the teams.
- e) Teams Structure Early practices & potential Season—Because it is a 10 person cap on the floor teams will be made up of 18 runners and 1 goalie & two coaches and that team will be split into two to create the groups. Groups of 10 including coaches and will be run like a camp. If/when we get the go ahead for a season we can mesh those two groups to make the teams. Colin will come up with drill packages. We may move players during the first few weeks if needed. We have talked about doing a staggered start; midget & bantam the first week of March, Peewee & novice later March; Tyke & mini tyke in April.

how that will work. This will run like a camp for a while. Payments will depend on how the season runs (if there are games etc)

- f) Subcommittees Evals, scheduling (age group coordinators) Would like age group coordinators to work with Robin on scheduling floor times for their age groups.
- g) The main reason we are doing evals this way (on paper with past data) is doing any kind of eval with small groups and no contact would not be effective as well it could be wasting time when the season could be shut down. This is the best way to effectively get the kids back on the floor. The teams may not be perfect, but we want to get the kids on the floor and have them enjoy themselves (Ty)
- h) This is really about what the current state is allowing; depending on the government we may see larger group sizes allowed very soon This is still workable and gets kids on the floor (Sean)

 - a. We may need some help on this. We are a little worried about locking our coaches in place. Will have Colin design a package that is 5-6 sessions long keeping in mind many of these kids have not had sticks in hand -- progressive drills. Instruction should be the same for the groups.
