Screening for Symptoms	User groups are required to screen participants as
	recommended by their Provincial Sport Organization. If a group
	is using the facility with no governing provincial body they are to
	track attendees, including their phone numbers.

Change rooms	Please come dressed to the facility as much as possible, change

	clean and disinfect between rentals. Showers will not be

Physical Distancing	Beaumont staff will monitor physical distancing periodically.
	Users will be required to communicate to their spectators that

Sanitation, cleaning &	A written cleaning & disinfecting schedule to be updated
Disinfecting	following the General Relaunch Guidance.
	Door handles, railings and high touch points will be sanitized
	regularly.
Spectators	Up to 100 spectators can be in the stands.
	We recommend no more than 2 spectator per athlete in the
	facility.
	User group may limit spectators under their provincial sport
	organization guidelines.
	Ensure you are physical distancing if you are a spectator.
Equipment	Groups and individuals are required to provide their own
	equipment. Nets will be provided on the ice surfaces. Chairs and
	tables can be requested for the banquet room during the
	booking process.
Isolation room	Isolation Room is located in the referee room. Please call the
	Operator on duty in the event you have an individual present
	COVID symptoms.
General Requirements	50 people maximum including coaches, officials and athletes on
	a playing surface at one time.
	Sports groups are to follow the AHS guidelines specific to their
	sport.
	There is no loitering in the lobby, parents and spectators are
	asked to remain outside or in the spectator area.
	Seating areas in the lobby will not be available.
	Emergency procedures remain in effect.
	Washrooms will be open.
