<u>Presidents Report</u>

- Welcome to 2021 Baseball season looking to get started around July 1st
- Last year we started August long weekend. We did a lot of things right, however there are opportunities to improve. We have processes in place to improve our programming. Looking forward to a 'normal' baseball season.
- Update from Brandon call with Dr. Strang today with sports groups. Discussed daily case counts coming down, and they are looking for lower double digits. Vaccines are factoring in to optimism. We should see outdoor activities returning sooner than we think – we could be on the field mid-June. Update from BNS coming mid-next week.
- Staffing BG Chris Lerette is no longer with Baseball NS (working with Soccer NS). Thanks were extended to Chris for his contribution over the last 8 years.
- BG has taken on a lot of Chris' responsibilities, and Bailey MacDonald is in the office for the summer. Still looking to revisit staffing in the fall.
- Reviewed strategic plan meeting was held in January, when we set some reasonable targets.
- Calendar of events will float depending on how Covid rolls out.

Update from Cory Boutilier

- In second wave of NCCP did 14 days of NCCP courses. To date we have 70 coaches signed up.
- With high performance teams, things remain shut down. Hopeful we will be able to re-start in a few weeks. 17U trained through winter. 15U was shutdown right after core team was picked. Will have another session before team is picked. 13U will be starting once it re-opens.
- Programming everything is on pause, anticipating Cory will still be able to fit in the programming over the summer.
- Mentoring program is beginning tonight.

<u>Umpires Report from Joel Rodgers</u>

- New website is up and running.
- 280 umpires registered in the province won't be enough, so are working with assignors to recruit. Female training session was last weekend.
- Will be umpiring from behind the pitcher to start (will be revisited after we start season).
