- 1. Call to Order
 - Called to order at 1:07 AM by Andrew Downs
- 2. Establishment of Quorum
 - We have established quorum.
- 3. Approval of the Agenda
 - Motion to approve

 - All agreed. Motion approved.
- 4. Approval of the Minutes from the previous Annual General Meeting, including all business arising from those minutes
 - Motion to approve

 - All agreed. Motion approved
- 5. Executive and Board Reports
 - President Andrew Downs referenced his update included in the AGM package.
 - o Experienced significant events last year that impacted operations.
 - O Baseball NS was awarded 'Province of the Year' at Baseball Canada meetings. Based on achievable objectives set out nationally.
 - o Hosted Senior Women's Nationals and North American Indigenous Games.
 - Review staffing update, including introducing Emma Hause. Increases capacity across the board.
 - o Hosting Atlantic Challenger Jamboree in August.
 - o Dartmouth hosting 22U National Championship.
 - o BNS is hosting Baseball Canada Convention in November at Pier 21.

- Outlined Priorities strategic plan, club licensing, Safe Sport, Club Support program.
- o In closing, he's been very proud of what we've accomplished over the last 7 years and will be re-offering.
- Umpires Update by Joel Rodgers
 - o Registration numbers are down in rural NS.
 - o Doing two female only clinics this year.
 - o Green Arm band program continuing 7 or 8 other team sports have adopted this.
 - Game reports show issues on-field are down.
 - Need to work with fans to improve off-field issues.
- Girls Baseball by Mike Crawford
 - o Referenced update in report.
 - Looking at increase in teams and players in Bluenose. We need more coaches and more umpires.
 - o Female coordinators are growing the game in their regions (will have 3 this year)
 - o Focusing on supporting tournaments in various regions with Girls Day this year.
- Technical Director Portfolio
 - Baseball 5 launched into schools, and Baseball Canada is now taking on a bigger role – creating more content. Determining the type of program this will be moving forward (grassroots or competitive).
 - Rally Cap is beginning, with 3 associations requesting hats so far. Last year focus was Cory teaching coaches, which will continue this year.
 - NCCP positive feedback about hybrid clinics, so those will continue.
- Office updates
 - SafeSport just rolled out from a PSO perspective
 - There are 12 steps that we need to go through we are in the process of submitting these this year
 - This will be ready by 2025, with a policy suite to be available to members
 / associations
 - Recreational Committee met last year, and we're in the process of finalizing our recommendations (will connect with Club Licensing program)
 - An email going out to all members / associations with new roles within the office and contact points

 - Question of whether the legitimacy of 18UAAA is compromised.
 - Number of AAA teams has gone up since this was implemented size of league hasn't gone down.
 - Brandon the format of the provincial team has been discussed, and we would need a proposal around this that is player centric. Explained how this discussion evolved when the decision was made 11 years ago.
 - No active discussion to change this
 - Brian example of pitchers last year only having 20 innings of playing time
 - Example of difference between 13U and 15U teams being the amount of games
